A Resolution to Amend the Constitution Establish Equal Gender Rights

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

RESOLVED, By two-thirds of the Congress here assembled, that the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution when ratified by the legislatures of three-fourths of the several states within seven years from the date of its submission by the Congress:

ARTICLE --

SECTION 2: The Congress shall have the power to enforce this article by appropriate legislation.

SECTION 3: This amendment shall take effect two years from its ratification.

A Bill to Limit Tobacco Farms in the United States

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. Tobacco Farms in the United States are limited.

SECTION 2. Tobacco farms are any farms that grow tobacco for commercial purposes. Limited is defined as allowing the farmer to obtain a living wage until the product grown can be changed or the farmer can find a new job.

SECTION 3. The Department of Agriculture will oversee implementation this bill.

SECTION 4. This bill will take effect four months after it is voted into law in order to give tobacco farmers time to repurpose the land.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Increase Investment in Advanced Nuclear Technology

- 1 **WHEREAS,** Energy independence is currently a primary objective for the United
2 States in order to decrease dependence on foreign oil and curtail
3 environmental degradation; and
- 4 **WHEREAS,** Even the development of domestic oil resources is ultimately
5 unsustainable as fossil fuel reserves are not unlimited; and
- 6 **WHEREAS,** Nuclear power is extremely efficient and has minimal environmental
7 harms; and nationals such as China and India are already investing in new
8 nuclear technologies that have the ability to increase efficiency while also
9 decreasing the likelihood of meltdowns or accidents; and
- 10 **WHEREAS,** Increased investment in future generations of nuclear reactors has the
11 potential to reduce the timeframe to their implementation; now,
12 therefore, be it
- 13 **RESOLVED,** That the Congress here assembled substantially increase federal
14 investment and subsidization in the research and construction of 3rd and
15 4th generation nuclear reactors; and be it.
- 16 **FURTHER RESOLVED,** That Liquid Fluoride Thorium reactors be the primary focus of this
17 investment.

A Resolution to Provide Economic Incentives to Private Industries Based in the United States

- WHEREAS,** In 2013, the United States was recorded to import 69.62% more than it exports, which equates to \$689 billion dollars; and
- WHEREAS,** In 2013, 60% of all the goods in the United States were foreign made, as opposed to 8% in 1960; and
- WHEREAS,** More imported goods lead to a decrease in leadership on the economic stage, shifting to China, Indonesia, and Egypt; and
- WHEREAS,** The United States still has an unemployment rate of 6.3%, compared to China's 4.1%; and
- WHEREAS,** Economic incentives have proven successful in the past; now, therefore, be it
- RESOLVED,** That the Congress here assembled make the following recommendation for solution to grant \$20 million dollars to currently existing and new American manufacturing industries that export to other countries and supply the United States itself; and, be it
- FURTHER RESOLVED,** That industries that provide full benefits and at least three dollars an hour above the minimum wage in their respective area will be granted \$40 million dollars in incentives.

A Bill to Increase the Federal Minimum Wage

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1.** The Federal minimum wage shall be raised from \$7.25 per hour to \$8.00 per hour.
- SECTION 2.** All employers in the United States who are not otherwise exempt must pay employees at least the Federal minimum wage and overtime pay of one-and-one-half-times the regular rate of pay as provided by the Fair Labor Standards Act (FLSA).
- SECTION 3.** In the case where an employee is subject to both the state and Federal minimum wage laws, the employee is entitled to the higher of the two minimum wages.
- SECTION 4.** This law shall be enforced by the Department of Labor's Wage and Hour Division.
- SECTION 5.** This law shall come into effect at the beginning of the 2016 fiscal year. All laws in conflict with this bill are hereby declared null and void.

A Bill to Increase Economic Investment in Pakistan

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States federal government increase economic investment in
3 Pakistan by increasing both bilateral trade as well as investment into
4 Pakistan's economic infrastructure.

5 **SECTION 2.** Economic infrastructure shall be defined as any structure specifically
6 designed to improve Pakistan's economy.

7 **SECTION 3.** The Department of Commerce will be charged with the implementation
8 of this Bill.

9 **A.** A total of two billion dollars shall be invested into these systems
10 within Pakistan over a period of two years.

11 **B.** If investment is properly implemented and furthers both the US
12 economy as well as the Pakistani economy, the Department of
13 Commerce will be charged with setting a further investment rate.

14 **SECTION 4.** The initial investment shall begin within 6 months of this bill's passage.

15 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Cease Taxing the Income of United States Citizens under the Age of 18 Years Old

- 1 **WHEREAS,** United States citizens under the age of 18 are unable to vote according to
2 the 26th Amendment to the Constitution as ratified in 1971; and
- 3 **WHEREAS,** Citizens under 18 years of age pay nearly 13% of their income to Social
4 Security, Medicare, Federal Income, and State Income taxes which cannot
5 be reclaimed; and
- 6 **WHEREAS,** These citizens cannot vote for local, State or Federal government officials
7 to represent them; and
- 8 **WHEREAS,** The United States of America was founded partially upon the ideal of
9 no taxation without proper consent and representation as stated in the
10 Declaration of Independence; now, therefore, be it
- 11 **RESOLVED,** By the Congress here assembled that United States Citizens under the
12 age of 18 years old with proof of birth and residency are exempt from all
13 taxes on their income including Social Security, Medicare, Federal
14 Income, and State Income taxes.

A Bill to Provide Criminal Liability for Gun Owners

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** A gun owner is criminally liable for any injury or death caused by a gun
3 they own unless it was being used for self-defense or it was contained by
4 a secure gun storage or safety device.

5 **SECTION 2.** **A.** Self-defense includes defense of oneself, others or property as
6 recognized under controlling law.

7 **B.** A Secure Gen Storage or Safety Device is defined in 18USC Sec. 922.

8 **SECTION 3.** The Bureau of Alcohol, Tobacco, Firearms, and Explosives will be
9 responsible for the enforcement of this act.

10 **A.** A Person whose gun causes bodily injury, whether accidentally or
11 intentionally, is liable for Aggravated Assault.

12 **B.** A Person whose Gun causes death, whether accidentally or
13 intentionally, is liable for Manslaughter.

14 **SECTION 4.** This law will go into effect immediately.

15 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Classify and Recognize Bitcoin as Money in the United States

WHEREAS, Bitcoin is a relatively deregulated and volatile system in its present state;
and

WHEREAS, A significant portion of Bitcoin transactions are used for clandestine,
illegal activity; and

WHEREAS, The insecurity of Bitcoin against price fluctuation and theft has led to
severe financial damages to investors; now, therefore, be it

RESOLVED, That the Congress here assembled make the following recommendation
for solution that Bitcoin be classified and recognized as money in the
United States; and, be it

FURTHER RESOLVED, That the House Committee on Financial Services be charged with
the task of drafting appropriate legislation for the regulation and taxation
of financial transactions made by any individual or business conducting
business in the United States in any manner involving Bitcoin.

A Resolution to Reduce Foreign Aid for Israel to Stabilize the Middle East

- WHEREAS,** Israel has been the largest cumulative recipient of U.S. foreign assistance since WWII; and
- WHEREAS,** To date, the US has provided Israel \$115 billion in bilateral assistance; and
- WHEREAS,** Per year the United States sends Israel 3.1 billion dollars in aid; and
- WHEREAS,** The US is the largest arms supplier to Israel, and this hinders Middle East foreign policy; and
- WHEREAS,** US aid has been counterproductive as weapons spur destabilization, undermine peace, and lead to increased regional conflict; and
- WHEREAS,** Large sums of aid have been an obstacle in proposed peace talks with Arab states; and
- WHEREAS,** Billions of dollars sent have led to economic repercussions within the US and also entangle American in many regional conflicts; now, therefore, be it
- RESOLVED,** That the Congress here assembled here reduce military aid to Israel by 25% over the next ten year budget plan.

A Bill to Expand the NSA's Power on Foreign Surveillance

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. Any foreign communications would be subject to NSA surveillance.

SECTION 2. Any and all communications will be subject to NSA surveillance.

- A. Any traffic flowing in and out of the United States will be openly monitored, including previously "privileged" diplomatic discussions.
- B. Communications such as; e-mail, calls, IM, etc. will be monitored.
- C. NSA will overrule the International Covenant on Civil and Political Rights (ICCPR), as this agreement is the only thing currently restricting the NSA from unbridled surveillance of both allies and enemies.

SECTION 3. Surveillance done by the NSA will combat and stop global terrorism.

- A. Terrorism being a global issue, the NSA is the only one to access this problem.
- B. The US Intelligence Budget will prioritize funding to the NSA.

SECTION 4. This Act shall take effect upon passage and shall be implemented immediately.

SECTION 5. All laws in conflict with this legislation are here by declared null and void.

A Bill to Repeal the USA PATRIOT Act

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** Repeal the uniting & strengthening America by providing appropriate
3 tolls required to intercept & obstruct Terrorism (USA PATRIOT) Act of
4 2001, which helps deter and punish terrorist acts.

5 **SECTION 2.** The US code of Federal Regulations defined terrorism as "...the unlawful
6 use of force and violence against persons or property to intimidate or
7 coerce a government, the civilian population, or any segment thereof, in
8 furtherance of political or social objectives." Section 802 of the USA
9 PATRIOT Act expanded the definition of terrorism to cover "domestic" as
10 opposed to international terrorism, expanding the type of conduct the
11 government can investigate as "terrorism."

12 **SECTION 3.** The Department of Justice will be responsible for overseeing the
13 implementation of the bill under the following conditions:

14 **A.** Those previously detained under the USA PATRIOT Act will be given a
15 fair and speedy trial before an impartial jury in the US Federal Court.

16 **B.** Anti-terror surveillance will occur only under probable cause.

17 **SECTION 4.** Implementation of this bill is effective within six months of passage. The
18 Department of Justice has two months to warn all branches affected by
19 this bill.

20 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
