A bill to Force Large Companies to pay corporate taxes.

section 1

The United States Federal government should adjust its current tax code to force every company to pay taxes. Companies such as apple, xerox and qualcomm profit millions of dollars but don't pay taxes. It is not fair because everyone has to pay taxes and companies that profit billions of dollars a year have to pay taxes but they are just avoiding them.

section 2

A company is defined as a multi-million dollar incorporated business. apple is profiting 12.1 billion\$ per year and every year apple is avoiding taxes. section 3

section 4

A Constitutional Amendment to the 14th amendment to revise Birthright Citizenship

Section 1:

Congress shall amend the 14th Amendment to the constitution to address current issues in the United States regarding Birthright Citizenship. Birthright citizenship should be changed to disallow illegal immigrants to have the right of birthright citizenship.

Section 2: BRC is a legal right to citizenship for all children born in a country's territory, regardless of parentage. Illegal Immigrant is defined as a foreigner who enters the U.S. without an entry or **immigrant** visa, especially a person who crosses the border by avoiding inspection or who overstays the period of time allowed as a visitor, tourist, or businessperson.

Section 3: The department of Homeland security will oversee the implementation of this bill.

Section 4: This bill will go into effect immediately after passage of this bill. States have up to 2 years to fully comply with this bill.

Section 5: All current laws that are in conflict with this bill are null and void.
