ESSENTIAL INFORMATION

Scrimmage Dates & Times: Tuesday, October 4, 2016; Tuesday, November 1, 2016, Tuesday, January 10, 2017; and Tuesday, February 7, 2017. Final registration takes place at 3:50 PM. Two rounds of each event will be held (one session of Congress), single-flighted, from 4:00 PM – 6:00 PM. We will confirm the schedule after registration closes for each scrimmage.

Events Offered: Policy Debate, Lincoln-Douglas Debate, Public Forum Debate, Congressional Debate, Extemporaneous Speaking, Persuasive Speaking (Original Oratory), Informative Speaking, Dramatic Interpretation, Humorous Interpretation, Duo Interpretation, and Program Oral Interpretation. No double entry is permitted. "Maverick" entry is not permitted in partnered events, though the tournament director may allow teams of three if extenuating circumstances are explained upon final registration.

Place: Registration takes place in Founders Hall (the cafeteria) on the campus of Charlotte Latin School, 9502 Providence Road, Charlotte, NC, 28277. Students and judges will be directed to their lounge area (which may vary by date) from the final registration table.

Food: Two slices of cheese pizza and bottled water will be available to all attendees for \$5.00. Otherwise, all attending competitors, judges, and coaches should plan to bring a snack or dinner.

Rules and Resolutions: The tournament will use NSDA rules and debate the varsity resolution corresponding to the month of the tournament, except in October when we will use the novice LD resolution. Congress legislation will be announced and posted at least one week in advance of each scrimmage and drawn from the state legislation bank. The use of manuscripts in interpretive events and notes in Extemporaneous Speaking and Original Oratory is allowed. Students of any experience level are permitted to enter, though coaches are encouraged to consider using their most experienced students as judges.

Registration: Enter online via tabroom.com, closing at 5:00 PM on the Friday prior to each scrimmage. Due to the heavy use of our campus in the evenings, space will be very limited (approximately 20 classrooms). Waitlists may be established and will be cleared as space permits immediately following the close of registration. Please understand that names placed on any waitlist should actually be available to attend. Hording of entries or otherwise manipulating the registration system will result in the offending school's invitation being revoked for

future scrimmages.

Judging Ratios: One judge per two teams or fraction thereof calculated independently in each of Policy, Lincoln-Douglas, or Public Forum debate. One judge per four entries or fraction thereof calculated by combined entry in Extemporaneous Speaking, Original Oratory, Dramatic Interpretation, Humorous Interpretation, and Duo Interpretation. One judge per eight entries or fraction thereof in Congressional Debate. Varsity students having attained at least the NFL Degree of Excellence (150+ points) are encouraged to attend as judges. Judging requirements will be strictly enforced. It is an absolute, non-negotiable certainty that any students entered beyond those covered by a school's registered judges will be denied. Extra judges beyond these requirements are welcomed and appreciated. Schools that habitually drop significant numbers of entries at final registration due to judging shortfalls will not be invited to attend future scrimmages.

Observers: Schools are encouraged to bring new students to watch rounds. All rounds are open to observers so long as they are a respectful audience. No competitor, judge, parent, or coach shall request that observing students be denied entry to a round, be denied the ability to flow the round, or be denied the ability to take said flow with them at the conclusion of the round. Scouting is strongly encouraged.

Supervision Requirements and Liability Release: It is essential that each attending school have a chaperone that is a legal representative of that school and that the participation of that school has been approved by its administration. Parent volunteers, unless in possession of a letter signed by the school principal authorizing them as a legal chaperone, are not adequate to meet this requirement. Charlotte Latin reserves the right to deny entry to any students, parents, and coaches who cannot demonstrate that their school has met this requirement. Entry via tabroom.com further indicates that the attending students, their parents, and their school take full responsibility for their participation in this program, assume all risks involved in said trip, and agree to hold Charlotte Latin School harmless for any accident, regardless of degree, and any injury incurred to said attendees to, from, and during said tournament, and do fully release Charlotte Latin School for any liability therefore.

Competitor Attire: Casual, though students are free to wear tournament attire should they so choose.

Results and Ballots: Records, ranks, and speaker points will be recorded as appropriate in each event. Judges are strongly encouraged to write exhaustive, constructive comments. A brief oral disclosure with critique is strongly encouraged at the conclusion of each round (including in speech events), time permitting. There will be no awards given at the conclusion of the scrimmage.

Fees: All entries are free. No hired judging is available.
