A Resolution to Amend the Constitution Regarding Limitations on the Office of President

- 1. Whereas, the United States Presidents over the past hundred years have been
- 2. older men over the age of fifty with three exceptions, and
- 3. Whereas, the country is twenty trillion dollars in debt and we have seven
- 4. million five hundred twenty-eight thousand unemployed citizens and only
- 5. sixty-three percent participation in the labor force according to the bureau of
- 6. labor statistics, and
- 7. Whereas, the country needs fresh ideas from younger minds from different
- 8. areas of the world to provide better leadership, therefore
- 9. Be it resolved that we amend Article II, Section One, Paragraph Five of the US
- 10. Constitution to change the qualifications for President of the United States, to
- 11. as follows:
 - a. The president must have been born outside of the US and
 - b. The president, though he/she must have lived in the US for at least one year, cannot have lived in the US for more than five years, and
 - c. Presidents must be between the ages of twenty five and fifty, and
 - d. Candidates shall be given ten additional electoral votes for each year of age closer to twenty five from thirty five, up to a maximum of one-hundred electoral votes, and
 - e. For each year of age above fourty closer to fifty, three electoral votes shall be removed, up to a maximum of thirty and
- 12. Whereas, other inherent flaws make it also necessary to amend Article II,
- 13. Section Four, so that the president, vice-president, and all other civil officers of
- 14. the United States, instead of being impeached and removed from office for the
- 15. conviction of treason, bribery, or other high crimes and misdemeanors, shall
- 16. instead be required to have been convicted of treason, bribery, or other high
- 17. crime or misdemeanor.

17		when publishing the tax returns.
18	Article V:	All other laws in conflict with this new policy shall hereby declared null
19		and void.
