REGISTRATION DEADLINES: Registration must be made by **11:55 p.m. Wednesday, November 9** through www.tabroom.com

Drops and name changes will be accepted until Friday November 11 at 6:00 p.m. Invoices will be prepared at that time. No late adds will be accepted. Saturday drops *at registration* will be assessed an additional charge of \$10.

CALL SATURDAY MORNING EN ROUTE TO THE MFA HOTLINE (370-4632) to confirm your team attendance and judge attendance to avoid the \$10 penalty.

REGISTRATION FEES: \$7.00 per entry (New schools \$3.50); Teams (Duo and PF) are two entries (\$14) Entry fees will be capped per MFA guidelines.

JUDGE REQUIREMENT:

LD:	one judge for every 2 LD entries
PF:	one judge for every 2 teams
Speech or Congressional Debate:	one judge for every 5 entries

Help the meet run smoothly and fairly by supplying your required, trained judges, including unaffiliated, in accordance with MFA rules.

Judges are expected to be available for ALL rounds of competition. Fines will be assessed for judges departing early unless cleared through Tabulation.

Note judge conflicts or shadow needs in your judge registration on Tabroom.com. Email the tournament host for any complex judge situations. Remember a parent cannot judge the category in which their child is competing.

Fractional entries round up (i.e. six Speech entries = 2 judges). Third, fifth, and seventh judge must be neutral.

- Speech: one judge for every 5 entries

There will be a limited number of extra judges available for hire. Fees for purchasing judges will be \$60 per judge.

Submit requests to hire judges via Tabroom.com by 6:00 p.m. Wednesday, Nov 9th.

Judges not registered by the time of arrival will be assessed a \$60 fee.

If you have extra judges:

1. Contact the Tournament Director so the judge can be added to the judge hire pool.

OR

2. Encourage the judge to [register with Tabroom.com](#) and enter themselves into the hire pool.

TIMERS: Please try to have judges bring some sort of timer/stopwatch.

FOOD: Lunch and snacks will be on sale for students in the cafeteria. If students do not want to purchase food, they should bring lunch and snacks. Complimentary breakfast and lunch will be provided for coaches and judges. Students should not leave the school.

Congressional Debate: Senate/House, as needed

Speech: All State Tournament Categories

Sweeps for Speech, Debate and Congressional – 1st three places

Individual awards for 1st – 5th in each category, HM as determined by TAB

Note that ties in record will be broken according to MFA guidelines.

Tabulation of awards follows standards adopted by MFA.
