

## A BILL TO INCENTIVIZE LIVING ORGAN DONATION

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States Federal Government shall establish a system that will  
3 incentivize living organ donation. This system will be created and  
4 implemented by a newly created Organ Donation Management  
5 Committee.

6 **SECTION 2.** The **Organ Donation Incentives System** shall reward donors by offering  
7 tuition or retirement assistance, or through a donation to a charity of  
8 choice.

9 The **Organ Donation Management Committee** shall consist of one  
10 representative of Centers for Medicare and Medicaid Services (CMS), one  
11 representative of the Department of Health and Human Services, and one  
12 representative of the Department of Commerce (to be selected by their  
13 respective divisions), in addition to one leading medical expert and one  
14 leading economist (to be selected by the Department of Health and Human  
15 Services and the Department of Commerce, respectively).

16 **SECTION 3.** \$200 million dollars from the Department of Health and Human Services  
17 budget will fund the creation and first year implementation of this system  
18 through the Organ Donation Management Committee.

19 A. The aforementioned committee shall meet six times a year to  
20 evaluate this system of organ donation incentives and make  
21 recommendations to Congress.

22 B. One year after passage, the aforementioned committee shall advise  
23 Congress on funding needed for long term implementation of this  
24 system.

25 **SECTION 4.** This bill shall take effect immediately after passage.

26 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## **A BILL TO BAN THE PROCESS OF HYDRAULIC FRACTURING**

**A BILL TO END THE SANCTIONS ON SUDAN IN ORDER TO CREATE A MORE EFFECTIVE  
POLICY**

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

**SECTION 1.** The economic sanctions currently placed on Sudan by the United States have not proven to be effective, and therefore a more aggressive policy is necessary.

**SECTION 2.** The sanctions on Sudan, that have been enforced since 1997, have only exacerbated the human rights violations and violence perpetrated by the Sudanese government. In order to properly address the issues still facing the citizens of Sudan, a more focused policy needs to be created.

**SECTION 3.** The Office of Foreign Assets Control will be responsible for overseeing the implementation of this bill. Following the enactment of this legislation, there will be a six-month period for the department to develop a more effective plan to replace the current sanctions and propose it to Congress. Should it be passed, then the sanctions will be removed and the new legislation will be in place.

A. If, at the end of the six month period, a new plan approved by Congress has not been created yet, then a three month period will allow a temporary bill to be passed that will minimize the damage being inflicted upon the Sudanese citizens currently as a result of the sanctions.

**SECTION 4.** This law shall go into effect at the start of the fiscal year 2017.

**SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Mandate All School-Age Children  
to Receive Government Sanctioned Vaccinations**

- Section 3.** The responsibility of enforcement of this bill will be laid upon the United States Center for Disease Control (CDC).  
A. The CDC shall be legally held responsible for the selection and implementation of their required vaccinations.
- Section 4.** This bill shall be implemented upon passage.
- Section 5.** All laws in conflict with this legislation are hereby declared null and void.

## **A Bill to Nationally Reform Driver's Education**

Be it enacted by this Student Congress here assembled:

Section 1: The driving age is eliminated. Persons can begin to learn to drive once they are physically able.

Section 2: All federal transportation funding to a state for roads, bridges, mass transit or any transportation purpose shall be reduced by 50% each year if that state continues to impose a minimum driving age and fails to follow the requirements of this bill.

Section 3: All persons learning to drive must undergo an intensive training program administered by the state transportation agency, which may be taught in schools, and which must be approved in its design and implementation by the U.S. Department of Transportation.

Section 4: To be eligible for licensure, a person must pass a comprehensive federally approved test of driving rules and regulations, as well as a federally approved practical driving test on actual public roads lasting at least 15 minutes.

Section 5: All legislation directly in conflict with this bill is hereby declared null and void.

**A BILL TO REQUIRE UNIVERSAL BACKGROUND CHECKS FOR FIREARM PURCHASES**

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

**SECTION 1.** A universal background check National Instant Criminal Background Check System (NICS) will be required for all firearm purchases taking place within the United States as well as all US Territories.

**SECTION 2.** Gun purchases are defined as “any exchange where ownership of a firearm is transferred from one individual or group to another individual or group.”

**SECTION 3.** Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) will oversee the implementation of this piece of legislation.

A. All citizens who are found to have made a purchase in a place other than a federally approved dealer or without a universal background check at the site of purchase will face fines up to \$10,000 USD and prison sentence of up to 2 years for the first offence.

B. A citizen who has repeatedly dodged such a background check will face a prison sentence of up to 10 years.

C. All firearms owners who have previously purchased a firearm without a universal background check using the National Instant Criminal Background Check System must do so by January 1, 2019.

D. Any firearms owners who do not submit to the background check outlined in Section 3 Sub Point C will be prosecuted based on the guidelines outlined in Section 3 Sub Points A and B.

**SECTION 4.** This bill will take effect 12 months after the time of its passage.

**SECTION 5.** All provisions in conflict with this legislation are hereby declared null and void.

### **A Bill Give Japan Greater Military Autonomy**

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2. **SECTION 1.** The United States shall withdraw 70% of its active military personnel from its
3. Japanese bases, retaining essential functions and personnel. The United States
4. shall give \$800,000,000 in military aid to Japan, and work with Japan's self
5. defense forces to better protect against regional threats.
6. **SECTION 2.** "Active military personnel" is defined as members of the US Armed Forces
7. under the United States Forces Japan (USFJ) command.
8. **SECTION 3.** The removal of troops shall be carried out by the US Department of Defense,
9. through the USFJ and United States Pacific Command (USPACOM); the
10. military aid shall be carried out by the United States Agency for International
11. Development (USAID).
12. **A.** The Dept. of Defense and USFJ shall have absolute freedom in deciding
13. which bases to close and what personnel to remove, but shall retain essential
14. intelligence, command, advisory, and fast mobilization forces.
15. **B.** Any missile installations in Japan shall remain operational and staffed.
16. **C.** The withdrawal shall take place over 1 year after this bill's implementation.
17. **SECTION 4.** This legislation shall be implemented after discussion with the Japanese
18. government, at least one year after its passage.
19. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

12 **SECTION 4.** This legislation shall be implemented immediately upon passage.
