### A Bill to Save American Lives

## A Bill to Decriminalize Prostitution

### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

- SECTION 1. The United States Federal Government will decriminalize prostitution.
- SECTION 2. Decriminalization is considered an abolishment of criminal penalties for violation of laws prohibiting prostitution.

  Prostitution is considered an exchange of payment for sexual activity between consenting adults.
- SECTION 3. National, state, and local law enforcement agencies will no longer arrest adult sex workers who are exchanging sexual services for money. The Department of Health and Human Services will mandate that healthcare services be provided to sex workers in a non-discriminatory way, and suspected or reported sex work will not be reported to law enforcement. The money that is saved through decriminalizing sex work can be reallocated to state and local healthcare agencies for more accessible STI screenings and to the Department of Homeland Security's anti-trafficking efforts.
  - A. Currently, human trafficking and prostitution are monitored and enforced by the Department of Homeland Security and law enforcement agencies.
  - B. Human Trafficking, especially of minors, is still illegal.
- SECTION 4. This legislation shall be enacted in January 2018.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Legalize Euthanasia

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

SECTION 1. The United States Federal Government will legalize assisted suicide for patients with the help of a physician.

SECTION 2. All physicians must undergo training in order to comply with patients who acquire the action of assisted suicide. Physicians may help in deciding the best option for ending the patient's life, whether it be overdose or lethal injection.

SECTION 3. Each state will oversee and regulate health care facilities that mandate euthanasia.

## A Bill to Make Advertising to Children Illegal

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

SECTION 1. Advertising to children will be made illegal and any persons who violate this law will be fined an amount dependent on the severity of the case.

SECTION 2. Children are defined as ages 0-12.

SECTION 3. The Division of Advertising Practices will oversee the bill and enforce it with administrative lawsuits. Advertising shall not cause moral or physical detriment to minors, and shall therefore comply with the following criteria for their protection:

- A. It shall not directly exhort minors to buy a product or a service.
- B. It shall not directly encourage minors to persuade their parents or others to purchase the goods or services being advertised.
- C. It shall not exploit the special trust minors place in parents or teachers.
- D. It shall not unreasonably show minors in dangerous situations.

SECTION 4. The implementation of this bill will occur within the first quarter of 2018.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Rescind the War Powers Resolution

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

- SECTION 1. The War Powers Resolution will hereby be declared null and void.
- SECTION 2. Congress must be notified of any military action within 48 hours of the occurrence.
- SECTION 3. The President cannot commit ground troops for more than 72 hours without a Congressional authorization of military force unless:
  - a. The commitment is a response to a formal declaration of war against the United States
  - b. The commitment is a response to violations of the Geneva Conventions, Hague Conventions, and all child protocols of the aforementioned.
  - c. The commitment is a response to a national emergency for the United States or one of her allies.
- SECTION 4. The President retains the right to veto declarations of war and Congressional authorizations of military force.
- SECTION 5. Funding of a military action does not expressly grant congressional authorization under this bill.

## A Bill to Ensure Paid Leave for Cancer Patients

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. Employers in the United States are required to give a paid leave for people diagnosed with cancer in order to ensure they have adequate time for treatment.
- SECTION 2. The amount of time they are given off will depend upon the stage and type of cancer they are diagnosed with, but will not exceed 50 days in total.
  - A. A doctor's recommendation with the expected timeframe, number of days, etc. will be submitted to the employer to ensure the employer is given adequate information to comply with this law.
- SECTION 3. The Department of Labor will oversee the enforcement of this legislation.
  - A. Employers that do not comply with this law will be fined \$2,000 for each offense.
- SECTION 4. This legislation will go into effect on January 1, 2018.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## The Social Security Reform Act

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. The current retirement age for Social Security will now be raised from 65 to 68 increasing the requirement age by 1 year every 2 years, over the span of 6 years.
  - A. Citizens are able to apply for partial benefits at the age of 60.
  - B. The current wage cap of \$118,500 will be increased to \$500,000.
  - C. Additionally, a new bracket of social security tax of a 7.5% Social Security tax rate will be implemented for people who have an income of over \$700,000 along with a wage cap of \$750,000.
- SECTION 2. "Partial benefits" refers to the ability to apply for Social Security earlier, but get less resources with every check.
- SECTION 3. The I.R.S will be in charge of implementation of this bill.
  - A. Someone who is currently filed as a widow/widower will receive an additional 50% increase in their monthly Social Security payout.
  - B. The employer Social Security tax rate of 6.2% will be cut to 5.5%. This applies only to businesses that have fewer than 75 employees.
  - C. If there is a surplus in the Social Security account, 35% will be earmarked to increase Social Security checks.
  - D. If a child is orphaned, that child shall receive their parents' social security payment until they reach the age of 25. The I.R.S must receive a death certificate of both parents and create a new form for the orphan's current guardians to fill out.
- SECTION 4. This legislation will be implemented at the start of the fiscal year of 2019.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Change the U.S. Graduation Requirements to Create Better Speakers

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. All students enrolled in High School must receive at least one credit of a Speech and Debate course in order to meet the graduation requirements.

SECTION 2. High School will be defined as grades 9-12 in the United States education system, and a Speech and Debate course is defined as any course that grants an Oral Fluency credit.

- A. An Oral Fluency credit may be earned by receiving a passing grade in: a Speech and Debate course, a theater or drama course, or a general education public speaking course.
- B. Active participation and membership in: a Speech and Debate club or academic team, a theatrical or drama club, or a mock trial team or club can, as determined by the club or team's advisor and the individual school's Student Services Coordinator or administration, also grant credit.
- SECTION 3. This bill will be enforced by the U.S. Department of Education, and the individual Departments of Education between each U.S. State will receive a sum of money equivalent to that of the average cost of one credit hour per student enrolled in said courses, for the implementation of such program.
- SECTION 4. This bill shall go into effect with the enrollment of the graduating class of 2024.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to End the Used Nuclear Fuel Stalemate

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. The Department of Energy is hereby instructed to complete and open Yucca Mountain as the national geologic repository for spent nuclear fuel as dictated in the Nuclear Waste Policy Act of 1982.
  - A. In parallel with the efforts to open Yucca Mountain, the Department of Energy is instructed to begin the licensing and construction of the Texas Waste Control Specialist "WCS" site for the interim storage of spent nuclear fuel.
  - B. This legislation also authorizes all land, water, and transportation rights that are required to open these facilities.
- SECTION 2. Spent nuclear fuel is the left over control rods from the nation's commercial nuclear sector, and not the U.S. weapons complex.
- SECTION 3. The Department of Energy in conjunction with the Nuclear Regulatory Commission are responsible with implementing this legislation. The Department of Transportation and in the Department of the Interior are responsible for granting the l and, water, and transportation rights.
  - A. This legislation requires that the Nuclear Regulatory Commission licenses Yucca Mountain and the WCS site, if they meet requirements terms of public safety and technical feasibility for 10,000 years.
  - B. The Treasury must allow the access to the Nuclear Waste Fund to fund the opening of Yucca Mountain and the Waste Control Specialist Site.
- SECTION 4. This legislation shall go immediately into effect.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Increase Social Security Pensions for Golden American Citizens

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. American citizens over the age of 65 will receive an annual yearly 5% raise in their social security after the first 2 year of receiving their payments.

SECTION 2. This annual increase will be funded by an increase in taxation on large corporations.

SECTION 3. The United States Social Security Administration under the federal government, along with a new board of Social Security in every state will ensure effective administration of this bill.

SECTION 4. The bill will go into immediate effect on July 1st, 2018.

SECTION 5. All previous laws that are in conflicted with this bill will henceforth be declared null and void.

## A Bill to Aid Low Income Families With College Costs

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. This bill would provide assistance to families who do not have enough income to fully pay for college. The following requirements would determine eligibility.
  - A. The capability to successfully demonstrate the completion of a minimum of 90 college credit hours.
  - B. Maintain a minimum grade point average of 2.00.
  - C. Are currently enrolled in an Oregon 4-year public college, and in their first 2 years of being enrolled have completed requirements Section 1, sub point a and b.
  - D. Been a permanent resident of Oregon for a minimum of 5 years.
  - E. Your household income does not exceed the median household income for the State of Oregon (currently \$50,000).
- SECTION 2. The State shall provide funding for 90 additional credit hours, only if the above criteria are met.
- SECTION 3. Funding for this program shall be through the Oregon Lottery.
- SECTION 4. The starting of this program shall commence at the start of the 2019-2020 academic school year.
  - A. The program will qualify to anyone who has not only met the requirements listed in section 1.
  - B. Also be the first year they have been enrolled in any Oregon Public 4-year institution.
- SECTION 5. All programs funded through the Oregon Lottery are now funded by The State Marijuana Tax, and all expenses from this bill would be used from 75% of the Oregon Lottery funding.
  - A. Additionally, all programs funded by the state Marijuana Tax are now funded through the Lottery Fund.
  - B. All excess money will be added into the State General Fund.

## A Bill to Shut Down Nationalized Lotteries

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. Federal, State, County, and City run gambling and lottery systems will be made federally illegal.

SECTION 2. Gambling and lottery systems are defined as chance-based activities in which money is exchange in return for the

improbable or probable ability to create a profit.

- A. This includes, Powerball, Scratch tickets, online poker, and all other government managed gambling systems
- B. This does not include the national or international stock exchange.
- C. This does not include casino style gambling on Native American Reservations.
- D. However, this does include casinos on non-Native owned land.
- SECTION 3. Discretion regulation will be managed by a new Federal Lottery Enforcement Commission which will be formulated out of the past Federal Lottery Commission, which shall be funded by the taxes currently in place on the remaining, legal gambling systems.
  - A. Any possible corruption will be investigated by The Federal Bureau of Investigation (FBI).
- SECTION 4. The provisions of this bill shall take effect on the first day of the year following the passage of this bill.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Delay Construction of Gerald R. Ford Class Carriers to Reassess Navel Strategy and Reduce Federal Expenditures

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. All further construction of Gerald R. Ford class aircraft carriers will be talked until FY 2027.

SECTION 2. Huntington Ingalls Industries ins instructed to delay construction on the ships until the specified date. Until the specified date, no further funds for construction will be provided by the government of the United States.

SECTION 3. The United States Department of the Treasury and the United States Department of Defense will have joint authority in enforcing this legislation.

- A. Payment for ships already completed will continue; payment for ships yet to be completed will be resumed on the specified date.
- B. The saved funding will be added to the federal budget to be apportioned in further spending resolutions.
- C. The saved funding may not be apportioned towards th construction of additional aircraft carriers before the specified date.

SECTION 4. This legislation will take effect beginning FY 2018 and end FY 2027.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Advance the U.S. – India Partnership

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. Under the joint jurisdiction of the Department of State and
  Department of Defense, the Arms Export Control Act will be
  amended to extend special foreign military sales status to India
  and institutionalize an annual defense policy dialogue to
  coordinate with the Ministry of Defense for the Government of
  India on
  - A. Combined military planning for missions such as disaster relief, maritime domain awareness, and other missions deemed to be in the national security interests of both countries
  - B. Defense procurement planning to include humanitarian assistance and border maintenance and control
- SECTION 2. "Special foreign military sales" status is a state classification of security assistance authorized by Arms Export Control Act (AECA).
  - A. The funding for provided weapons shall come from the India's national funds and shall be subsidized on a per purchase basis
  - B. India has become an instrumental partner in delivering humanitarian and disaster relief in the Asia-Pacific region as the India Air Force has sued United States-origin C-130 and C-17 aircraft to evacuate Indian, American, and third-country nationals and send relief supplies.
- SECTION 3. The President shall include India on the list of countries eligible for the strategic trade authorization exception under section 740.20(c) (1) of title 15, Code of Federal Regulations.
  - A. If India utilizes US military hardware and software in a manner that is not conducive to US strategic interests, subsidies provided shall be voided and India shall be responsible for the full cost of its purchases.
- SECTION 4. This legislation will go into effect January 2018
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Depoliticize Intelligence

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. The Director of the Central Intelligence Association (CIA) shall have a ten-year term limit.
- SECTION 2. A term limit expiring after 10 years shall be installed to the position of CIA director in order to depoliticize the position and promote greater honesty and communications between the offices of US government.
- SECTION 3. The office of the President of the United States (POTUS) shall remain responsible for appointing new CIA directors when the need arises either due to term expiration or a vote of no confidence.
  - A. Replacements shall be conducted on the first Tuesday of February in years ending in -9 (e.g. 2019, 2029, 2039, etc.).
  - B. In the case of perceived danger, the legislative branch may conduct a 'Vote of No Confidence' requiring a supermajority in each legislature, beginning in the House of Representatives. A successful vote will result in the removal of the CIA director.
  - C. In the case of director elimination POTUS shall select a temporary director whose term will expire on the next, first Tuesday of a year ending in -9.
  - D. All appointees must be confirmed by the Legislative branch by majority votes in each congress.
- SECTION 4. The provisions of this bill shall take effect on February 5<sup>th</sup> of 2019
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Dramatically Increase Federal Funding for NASA

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. The annual budget for the National Aeronautic and Space Agency (NASA) will be increased from its current level of \$19.5 billion to \$60.0 billion, adjustable for inflation, not to be decreased until January 1st 2028 at the earliest.
  - A. The funds will be allocated within NASA according to the discretion of the NASA Administrator, in order to pursue the objectives listed in NASA's "What's Next for NASA?" document.
- SECTION 2. To fund this policy, The United States federal government will increase the corporate income tax rate by a discretionary amount for the top 1% of American companies.
  - A. The "top 1%" of companies will be defined in terms of gross income.
  - B. The "discretionary amount" will be computed each year to produce \$40.5 billion in revenue, adjustable for inflation.
- SECTION 3. The Department of the Treasury will oversee the enforcement of the bill along with the following specific enforcement mechanism:
  - A. The Internal Revenue Service (IRS) will execute the computation and collection of the "discretionary amount."
- SECTION 4. This bill shall be implemented January 1<sup>st</sup>, 2018.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Provide Housing for Veterans

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The U.S. Government will provide housing for veterans who are unable to secure and sustainable living situation for themselves.

Housing will be defined as a building with a foundation, roof, heating and private space, essentially warming shelters, yet the Veterans will occupy them until they can provide a living space for themselves. Veterans will be eligible based identification provided by the U.S. Department of Veterans Affairs. Additional funding for the VA program will be obtained from the U.S Department of Defense.

SECTION 3.

SECTION 2.

The U.S. Department of Veteran's Affairs, which is part of the U.S. Department of defense, is best situated to provide this service with assistance from the Department of Health and Human Services. Although there are programs in place, they continue to fail to meet the needs of all homeless veterans. "Of the estimated 79,500 homeless veterans who contacted the VA's National Call Center for Homeless Veterans last year, nearly 27 percent were unable to reach a counselor", says the Washington Times, the call center is a faulty system and providing no help or housing for our veterans. After serving our country, our veterans deserve to have basic shelter.

SECTION 4.

This shall take effect once funds are obtained for one of these shelters in each state, one year at the most, the design of the buildings will be decided before then as well.

SECTION 5.

This law supplements current laws (homeowner's/ mortgage loan viability law) with the intent of closing any discrepancies, or faults, while providing care for our veterans.

## A Bill to Help Low Income Families Pay Child Care

### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. The United States Federal Government shall allocate \$100 million to a program to help fund child care for low income families.
  - A. A program will be developed to help set up a fund to pay the half cost of families child care bills.
  - B. Funding will come from the overwhelming military budget.
- SECTION 2. "Child Care" shall be defined as the care of children by a day care center, babysitter, or other provider while parents are working.
  - A. "Low Income families" shall be defined as families who have an income of \$20,090 or less.
  - B. Military budget shall be defined as the budget given to the military to help with combat.
- SECTION 3. The implementation of this legislation shall be overseen by a new department called the child witness protection program.
- SECTION 4. This legislation shall be implemented on April 7, 2019.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
