Resolution Granting Statehood To Puerto Rico & Guam

Whereas, The U. S. Territories of Puerto Rico and Guam have been part of the United States

since the end of Spanish-American War in 1898; and

Whereas, Puerto Rico is in desperate need of financial support from the U.S.; and

Whereas, Guam has been and continues under direct threat from North Korea; and

Whereas, The United States has a moral duty to either allow them complete autonomy or

to grant them Statehood; therefore

Be it Resolved, That the U.S. Territories of Puerto Rico & Guam should be named the 51st & 52nd states of the United States of America.

A Resolution To End All Demographical Questioning

Whereas, The United States Government conducts a census every ten years; and

Whereas, The purpose of the census is to count people in order to establish

proper representation in the House of Representatives and for the Electoral

College; and

Whereas, All U.S. citizens that are at least 18 years old are eligible to vote; and

Whereas, It is not relevant what your race, gender, religious affiliation, ethnic background,

sexual orientation, marital status, etc to establish the census count; therefore

Be it Resolved, that starting with the official United States Census for 2020, no demographical questions will be asked other than name, age, and address in order to achieve the intended purpose of the census.

A BILL TO DECREASE HERION ADDICTION AND OVERDOSE THROUGH DECRIMINALIZATION

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION I. In order to curtail the heroin epidemic, the possession of heroin by removed from the scheduled class of illegal narcotics. Current offenders serving time for this charge will also be released upon passage of the bill.

SECTION II. Decriminalization refers to the process of removing the punitive components of law enforcement in regards to possession or usage of heroin. Heroin is defined by its scientific name and components diamorphine.

SECTION III. The Drug Enforcement Agency will oversee implementation of this bill. All those found to be abstaining from enforcing will be fined \$1,000 per denied inmate.

SECTION IV. The act will take effect January 1st, 2019.

A BILL TO ABOLISH THE ELECTORAL COLLEGE IN FAVOR OF A DIRECT NATIONAL VOTE

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION I. That the United States Congress should amend the U.S. constitution to abolish the electoral college and replace it with a direct national vote for president.

SECTION II. The United States Congress will amend the constitution to abolish the twelfth amendment. This would effectively create the conditions necessary to establish a national popular vote.

SECTION III. Voting will continue to be the responsibility of state electoral regulation bodies, but votes will now be counted collectively rather than towards an elector.

SECTION IV. The act will take effect immediately and will be in effect for the upcoming presidential election in 2020.

1	WHEREAS,	Various states including Florida, Indiana, Kentucky, North Dakota, Ohio,

3		or ban experimentation, research, and/or sale of aborted fetuses; and
4	WHEREAS,	These research restrictions have greatly delayed areas of study such as

7		medical facilities around the nation save lives; and
8	WHEREAS,	The restrictions set forth by these states have set back further
9		advancements in the medical field that could save lives of future
10		generations; and
11	WHEREAS,	Fetal research is being obstructed by restrictive laws, and it is necessary
12		to improve knowledge of various areas of medical science; now,
13		therefore, be it
14	RESOLVED,	That the Congress here assembled encourage fetal research on aborted
15		fetuses with the consent of the donor.

TFA Fall 2017 Item 7. A Bill to Establish Fair Legislative Districts

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- redistricting commissions every ten years for federal elections.
- 4 **SECTION 2**. Independent Redistricting Commissions shall be defined as nonpartisan

 - **A.** Designs for the border wall will be submitted to the federal government for evaluation. Final choices on the design of a physical barrier as well as sensor systems will be made by the federal government.
 - B. Construction on the border wall will begin within six months of passage of this legislation and will continue to be funded until the border wall's construction is totally finished along our southern border.
- SECTION 2. Border wall can include a physical barrier and/or sensors to detect illegal crossings of the United States southern border.
- **SECTION 3.** The Department of Homeland Security will be charged with full implementation.
- **SECTION 4.** Funding of the border wall will occur immediately upon passage of this legislation and will continue until construction is completed.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void. *Introduced for Congressional Debate by Bellaire High School.*

12	SECTION 2. A commercial bank is defined as a depository entity that
13	manages the deposit accounts of individuals, businesses, and uses money on
14	deposit to make loans to public. An investment bank is defined as a bank
15	that facilitates the buying of stocks, securities, bonds, and other investments
16	as well as offering initial public openings.
17	SECTION 3. This legislation will be overseen and enforced by:
18	A. The Securities and Exchanges Commission which will ensure that
19	information regarding the prohibited actions in Section 1 of this
20	legislation will be provided to;
21	B. The Federal Deposit Insurance Corporation in order to survey
22	compliance.
23	C. The Department of Justice will litigate against commercial banks and
24	investment banks found non-compliant by the Federal Deposit
25	Insurance Corporation.
26	SECTION 4. This legislation will be implemented at the start of Fiscal
27	Year 2019.

3		citizenship for undocumented immigrants currently residing in the United States under the

7		B. Applicants will be required to provide documented proof of continuous residence in the
8		United States for a minimum of 5 years.
9		1. Proof of residence may include, but is not limited to, mortgage payment receipts, rent
10		receipts, utility payments, pay stubs, or school enrollment documents for minors.
11		2. Children under school age may be exempt from this requirement.
12		C. All applicants will be subject to background checks. Conviction of a felony may be grounds
13		for rejection of the residency application.
14		D. Granting of resident status will allow each individual to begin the residence requirement for
15		naturalization and US citizenship
16	SECTION 2.	Immigrants granted resident status will be allowed to work in the US and will be eligible to receive
17		any benefits or services available to non-citizen legal residents.
18	SECTION 3.	The Department of Homeland Security will be responsible for the implementation and
19		enforcement of these provisions.
20	SECTION 4.	This law will take effect on January 1, 2018.

TFA Fall 2017 Item 27. A Bill to Limit the Speed of High Frequency Trades

- **SECTION 1**. All High-Frequency Traders shall be prohibited from connecting to U.S. Stock Exchange servers in order to prevent the spoofing of supply and demand.
- SECTION 2. A. High-frequency Trading (HFT) is a program trading platform that uses powerful computers to transact a large number of orders at speeds faster than a second. It uses complex algorithms to analyze multiple markets and execute orders based on stock market conditions.
 - **B.** Spoofing under the 2010 Dodd-Frank Act is defined as "the illegal practice of bidding or offering with intent to cancel before execution."
- SECTION 3. Securities and Exchange Commission will oversee the enforcement of this legislation by fining all companies that fail to comply with these standards by claiming 5% of profits earned for the next 5 years.
 - A. If a company then fails to pay their fees, the fees will then be increased by a further 5%.
 - B. On a company's third offense that company's broker license will be revoked.
- **SECTION 4.** Legislation will be implemented and enforced by October 1st 2019.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void. Introduced for Congressional Debate by Cypress Creek High School.

 - **B.** Increase the required investment needed to obtain the EB-5 visa to \$1.2 million (\$800,000 for a Targeted Employment Area) and the required job creation total to 25 American jobs.
 - **C.** Add a new criterion granting automatic U.S. citizenship (after the 2-year waiting period) to those who invest \$2.5 million (\$1.6 million for a Targeted Employment Area) and create 50 American jobs.
 - **D.** Combat investment fraud by mandating disclosure of all monetary transactions, creating an oversight committee on all USCIS Regional Centers, and banning any persons with criminal records from being a party working on the investment.
- SECTION 2. EB-5 shall be defined as a program that allows entrepreneurs to apply for U.S. permanent residency through the investment in a job-creating commercial enterprise in the United States. Targeted Employment Area shall be defined as any rural area or an urban area with an unemployment rate at 150% the national average.
- **SECTION 3.** The United States Citizenship and Immigration Services (USCIS) shall be tasked with the execution of this legislation.
 - C. Those found guilty of participating in fraudulent activities while working on an investment provided by the EB-5 program shall be fined \$2,000,000.
- **SECTION 4.** This legislation will be implemented beginning fiscal year 2019.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
