



Venezuela Intelligence Report 1/5/18

11/30/17: Since the measure failed the Venezuelan opposition force Primero Justicia has been all but destroyed due to a lack of funds and weapons to effectively fight the expansive power of the Venezuelan military with Russian assistance. As of now President Maduro has dissolved the legislature and courts and has consolidated power in himself and twelve cabinet members. Marshall law has been instituted across the entire country, estimates range but between 1,000 -10,000 extrajudicial killings of political dissidents across the country. Leaders of Primera Justicia have been living in exile in the United States. Public support has diminished for Nicolas Maduro and poverty has reached all time historic highs.

12/17/17: Russian forces have not left the country and begun to concentrate on the western border with Colombia along with the Venezuelan military.

1/5/18: The United States embassy has been overrun by forces that appear to be Colombian revolutionary group ELN and hold hundreds of hostages as well as assassinating the ambassador. United States intelligence has found large amounts of money flowing to this group from the Venezuelan government. The Venezuelan Military has also begun to engage the Colombian military in the departments of Arauca and Vichada in an apparent attempt to annex territory from Colombia.

A Bill To Invade Venezuela

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** The United States will send military forces to invade Venezuela and
2 Venezuelan held territory in order to overthrow the Venezuelan
3 Government.
- 4 **SECTION 2.** “Military Forces” shall be defined as 100,000 troops as well as a
5 combination of tanks, aircraft, and warships at the discretion of the
6 Department of Defense.
- 7 A. “Venezuelan held territory” shall be defined as geographic territories that contain
8 Venezuelan military forces outside of Venezuela.
- 9 B. “Venezuelan Government” shall be defined as the government currently led by
10 President Nicolas Maduro based in Caracas, Venezuela.
- 11 C. Funds for the offensive shall be allocated from the existing Department of Defense
12 budget.
- 13 D. The U.S shall send special forces to liberate hostages in the U.S embassy in Bogota,
14 Colombia at the discretion of the Department of Defense
- 15 **SECTION 3.** The Department of Defense shall oversee the implementation of this
16 legislation.
- 17 **SECTION 4.** This bill will take effect immediately.
- 18 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Declare War On Venezuela

- 1 **WHEREAS,** The government of Venezuela has infringed on Colombian territory,
- 2 **WHEREAS,** The government has refused to reinstate its governmental institutions
- 3 and civil liberties,
- 4 **WHEREAS,** The existence of a radical regime threatens the peace in the entirety of
- 5 Latin America,
- 6 **RESOLVED,** That the Congress here assembled declare war on The Republic of
- 7 Venezuela.
