A Bill to Increase Federal Funding to the Research of Cancer**

	HASTINGS
1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1. The annual funding to the National Institute of Health (NIH) for the fiscal
3	years of 2019 and beyond shall be increased to 118 percent of the fiscal
4	year budget allocated to the NIH for the fiscal year of 2018 in order to
5	allow the NIH to expand their scientific knowledge of carcinogens.
6	SECTION 2.
7	A. Scientific Knowledge is defined as the body of information accepted by
8	the global scientific community through peer review to be true.
9	B. Carcinogens are defined any substance, radionuclide, or radiation that
10	promotes carcinogenesis, the formation of cancer.
11	SECTION 3.
12	A. The NIH and the Department of the Treasury shall ensure that the NIH
13	receives all allocated funds in this piece of legislation.
14	B. The Director of the NIH shall oversee that the funds are used specifically
15	for the research of carcinogens
16	SECTION 4. This legislation shall become effective at the start of the 2019 Fiscal Year.
17	SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Amend the Constitution to Restore Voting Rights for All Citizens of the United States**

LINCOLN HIGH

1	RESOLVED,	By two-thirds	s of the Congress here assembled, that the following article
2		is proposed a	as an amendment to the Constitution of the United States,
3		which shall be	e valid to all intents and purposes as part of the Constitution
4		when ratified	d by the legislatures of three-fourths of the several states
5		within seven	years from the date of its submission by the Congress:
6			ARTICLE
7		SECTION 1:	All persons – whether imprisoned or free – shall by no act
8			of congress or other body of government be prohibited
9			from exercising a free and unimpeded right to the voting
10			franchise in all elections held throughout the United
11			States.
12		SECTION 2:	All amendments in conflict with this amendment are
13			hereby repealed and laws or statutes in conflict
14			unconstitutional.

A Bill to Ban Federal Dollars from Being Spent on Abstinence Only Sexual Ed Programs

LINCOLN SOUTHEAST

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	Federal dollars shall not be allocated to any sexual education programs
3		which exclusively offer abstinence only approaches to the curriculum.
4	SECTION 2.	
5	A	. Abstinence only sexual education is defined as any program that aims to
6		inform students of any age on matters about or relating to sexual health,
7		human sexual reproduction, or human sexual identity that exclusively
8		advocates for abstinence and/or provides scientifically inaccurate
9		information about reproductive medicine.
10	В	. Comprehensive sexual education is defined as any program that aims to
11		inform students of any age on matters about or relating to sexual health,
12		human sexual reproduction, or human sexual identity that provides age-
13		appropriate information about sexually transmitted diseases,
14		contraception, or other matters of sexual health.
15	SECTION 3.	The Department of Education (DOE) will oversee this legislation.
16	А	. A new branch of the DOE will be created to manage this oversight: the
17		Branch of Sexual Education.
18	В	. All schools wishing to secure federal aid to offer sexual education
19		programs must submit the curriculum and/or curricular program to the
20		Branch of Sexual Education and demonstrate that the
21		materials/programs are compliant with this legislation.
22	SECTION 4.	This legislation will go into effect upon the start of the 2020-2021 school
23		year.
24	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ban the Practice of Tip Pooling

(UNCLAIMED)

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. In the United States, the practice of tip pooling will be prohibited.
- SECTION 2. *Tip pooling* is defined as an approach to tipped wages that allows
 employers to collect the tips of employees who earn at least the federal
 minimum wage and share those tips with non-tipped workers.
- SECTION 3. The Department of Labor will be tasked with enforcing this legislation,
 with violators will be subject to applicable penalties as established by the
 rules of the Fair Labor Standards Act.
- 9 SECTION 4. This legislation will go into effect on January 1, 2020.
- 10 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ban the Practice of Fracking in the United States

ELKHORN SOUTH

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- SECTION 1. Fracking is hereby banned for use in mining or any other purpose
 throughout the United States.
- SECTION 2. Fracking is defined as the practice of injecting waste water and/or
 chemical compounds into the Earth with the intention of breaking up the
 deep rock layers to release pockets of natural gas for collection.
- 7 SECTION 3. This bill will be enforced by the Environmental Protection Agency.
 - A. Companies or individuals found to be violating this law will be subject
 - to fines no less than 1 million dollars for the first offense and no
- 10 fewer than 2 years in federal prison.

- B. Established penalties will double upon each offense.
- 12 **SECTION 4.** This legislation will take effect on January 1, 2019.

A Resolution to Encourage the United Nations to Apply Pressure to Russia's Arms Manufacturing Efforts

A Bill to Hold Companies Accountable for Data Insecurity

CEDAR RAPIDS KENNEDY

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2	SECTION 1.	All companies operating within the United States will be responsible for
3		providing any customer whose personal data is compromised by any
4		action or inaction of the company with free credit monitoring services for
5		a period of no less than five years after the breach and must make those
6		persons impacted by the data breach aware of both the breach and the
7		services available to them as required by this bill within one month of the
8		discovery of the breach itself.
9	SECTION 2.	
10	A	. Personal data is defined as any sensitive information that is centrally
11		important to protecting one's identity and credit.
12	В	. Breach is defined as any compromise of personal data that results in that
13		data becoming vulnerable to outsiders and unsecured.
14	SECTION 3.	The Federal Trade Commission will be tasked with enforcing this
15		legislation.
16		A. Any company found to be in violation of this law will be subject to a
17		minimum fine of \$25,000 for each individual violation
18	SECTION 4.	This bill will go into effect one year after passage.
19	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Provide Oversight to the Federal Election Process

OMAHA NORTH

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. All elections for federal offices shall be administered by a Committee for Federal Elections. This Committee, under the oversight of the Department of Justice, shall standardize procedures for all elections of federal officials across the country. SECTION 2. The Committee shall bear responsibility for the following: A. Creating standards for and verifying voter eligibility for federal elections B. Identifying polling locations **C.** Hiring and training poll workers D. Procuring and testing technology for electronic balloting E. Collecting, verifying, and ratifying election results. SECTION 3. The Department of Justice will oversee the creation of the Committee for Federal Elections. The chair of the Committee shall be appointed by the president, with the advice and consent of the Senate. **SECTION 4.** This committee shall be in place by March 2018, to oversee the November 2018 elections. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Mandate Release of Video Footage in Officer-Involved Shootings

LINCOLN EAST

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. A. In all cases where a law enforcement officer is involved in an incident involving the discharge of firearms which results in the injury or death of a suspect, all unedited video footage of the incident must be turned over to the Department of Justice within 24 hours.

B. All such footage must also be made available to any interested media outlets within 72 hours after the incident.

- **SECTION 2**. Video footage may be from dashboard cameras, body cameras, helicopter cameras, drone videos, embedded media sources, or any other means of recording the incident which are controlled and held by the law enforcement agency.
- **SECTION 3.** The Department of Justice will oversee enforcement of this legislation, and will examine video footage turned over to determine if the civil rights of the victim were violated during the incident.
- **SECTION 4.** This shall take effect on January 1, 2018.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Protect Military Interpreters

MILLARD WEST

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1.** All foreign nationals who served as an interpreter for the United States military during the conflicts in Iraq and Afghanistan shall receive lawful permanent resident status within the United States.
- SECTION 2. Such status may also be extended to the immediate family of the interpreter. This status shall not be infringed by any executive order currently issued, or which may be issued in the future.
- SECTION 3. The Department of Defense will identify those who have served in such roles in the conflicts in Iraq and Afghanistan. The Secretary of Defense shall coordinate with the Secretary of State and the Secretary of Homeland Security to insure that the appropriate documentation is issued. Funding to provide transportation to the United States for the interpreters and their immediate families shall come from the current military personnel budget.
- **SECTION 4.** This shall take effect immediately upon passage.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to End the Military's Use of Weaponized Drones

LINCOLN NORTHSTAR

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. No branch of the United States military will be permitted to utilize weaponized drones
- **SECTION 2.** A weaponized drone is defined as a powered, aerial vehicle that does not carry a human operator, uses aerodynamic forces to provide vehicle lift, can fly autonomously or be piloted remotely, can be expendable or recoverable, and can carry a lethal payload equipped with lethal weapons, otherwise referred to as a weaponized unmanned aerial vehicle (UAV).
- **SECTION 3.** The Department of Defense (DOD) will oversee the implementation of this bill and ensure that weaponized UAV's are no longer flown in foreign countries or the United States.
- **SECTION 3A.** The Department of the Army under the DOD will enforce the halt of the use of Weaponized Drones.
- **SECTION 4.** This bill is to go into effect immediately upon its passage.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
- **SECTION 6.** Any military personnel found to be in violation of this law will be subject to court martial, a bad conduct dismissal from the armed services, and the forfeiture of all post-service benefits associated with their tenure in the armed services.
