- A. The United States will aid Bangladesh in providing food, shelter, safety, and medical assistance to the refugees fleeing Myanmar.
- **Section 4.** This bill will go into effect immediately after passage.
- **Section 5.** All laws in conflict with this legislation are hereby declared null and void.

The Department of State shall oversee the implementation of Section 1B. The Department of Defense and USAID shall work in conjunction with the United Nations to implement Section 1C.
- **SECTION 4.** This bill will take effect immediately upon passage.

#### A Bill to Pilot a Federally Funded Firearm Buyback Program

- SECTION 4. This bill shall be implemented upon passage of this legislation and will remain law for five (5) years where its effectivity will be evaluated and then voted on for an indefinite extension.

#### A Bill to Reform Illicit Narcotic Use to Combat the Current American Drug Crisis

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The punishment for possession of illicit narcotics up to a 10-day supply is no longer a 1st or 2nd degree federal felony, and instead consists of a citation and mandatory appearance at a discussion panel consisting of legal, social, and psychological experts.

A. Rehabilitation care and treatment to discourage the use of narcotics and help fight addiction to these substances will be available for all users of narcotics free of charge and funded by the federal government.

- SECTION 2. Illicit narcotics are designated recreational drugs including the varying forms and variations of Cannabis, Ecstasy, Methamphetamine, Cocaine, and Heroin Opioids. A 10-day supply of each of these substances is defined as: 1 gram of Heroin, Ecstasy, or Methamphetamine, 2 grams of Cocaine, or 25 grams of Cannabis.
- SECTION 3. The Departments of Justice and Health and Human Services will jointly oversee the implementation of this bill. \$200 billion will be allocated to implement this bill from the Federal Budget yearly beginning in the first fiscal year after its passage.
- SECTION 4. This law will be implemented on January 1, 2019.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## An Act to stop Israeli occupation through the halting of aid and the imposition of sanctions

#### A BILL TO INVEST \$600B TO REBUILD OUR FAILING WATER SYSTEM

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. The water infrastructure of the US, no longer considered acceptable, must be rebuilt and upgraded to prevent further leaks and contamination.
- **SECTION 2**. The water infrastructure of the United States includes dams, reservoirs, water treatment plants, pipes, and pumping stations, along with any other transportation method necessary to carry water for use nationwide.
- **SECTION 3.** The Environmental Protection Agency (EPA) will be responsible for overseeing the implementation of this bill.
  - A. The total money invested is \$600B in \$30B increments added to the Federal Budget with each Fiscal Year (FY).

  - D. The \$30B at each FY Proposal can be taken from the military budget, or any other budget exceeding its necessary amount in proportion to the rest of the budget breakdown.
- **SECTION 4.** This proposal will be implemented over a 20 year period, with the first \$30 billion increment in FY 2019.

#### A BILL TO IMPROVE ACCESSIBILITY TO AFFORDABLE PRESCRIPTION DRUGS

#### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. A. The Secretary of Health and Human Services shall, within 180 days of enactment of this bill, issue regulations allowing wholesalers, licensed U.S. Pharmacies, and individuals to import qualifying prescription drugs manufactured at FDA-inspected facilities from certified Canadian sellers. After two years, the Secretary shall have the authority to permit importation from countries in the Organization for Economic Co-operation and Development (OECD) that meet specified statutory or regulatory standards that are comparable to U.S. standards.
  - B. The Secretary of Health and Human Services shall now have the appropriate authority to negotiate pharmaceutical prices with on behalf of Medicare Part D. C. "Pay for Delay" deals are now illegal.
- SECTION 2. A. Certified foreign sellers are defined as firms that (1) have been in existence for at least five years and has a purpose for existing other than for this program; (2) if selling to an individual, does so only after receiving a valid prescription; (3) can certify that the physical premises and data reporting procedures and licenses are in compliance with all applicable laws and regulations in Canada, and has implemented policies to monitor compliance; (4) conduct ongoing and comprehensive quality assurance programs, including blind testing; (5) agree that laboratories approved by the Secretary shall be used to test product samples; (6) receive a certification from the Secretary of Health and Human Services that they meet the above criteria, including any of the regulations determined by the Secretary of Health and Human Services, and renew their certification every two years.
  - B. Qualifying prescription drugs must have the same active ingredient(s), route of administration, strength as drugs approved in the U.S, and exclude controlled substances, anesthetic drugs inhaled during surgery, or compounded drugs.

    C. "Pay for Delay" deals are defined as deals made between a pharmaceutical company manufacturing brand-name pharmaceuticals and a generic pharmaceutical competitor that delays the entrance of generic pharmaceuticals into the market.
- **SECTION 3.** The Department of Health and Human Services shall oversee implementation of this law.
  - A. Funds necessary to administer Section 1A shall come from an annual fee paid by certified foreign sellers set by the Secretary of Health and Human Services.
  - B. Non-compliance with the ban on "pay-for-delay" deals shall result in a fine to be determined by the Secretary of Health and Human Services.
- **SECTION 4.** This bill shall take effect immediately upon passage.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Lower the Drinking Age to Protect the Rights of Young Adults

**Section 3:** Resources dedicated toward nuclear programs could be better reallocated to

other programs and services. Peacetime activities could be converted to productive peacetime

activities, including (but not limited to) the development of carbon-free energy, healthcare,

housing, and education.

Section 4: The addition of the United States in any multilateral treaty makes it more likely for

multilateral agreement across the world. The active promotion of the treaty by the United States of

America would only heighten this effect and raise the chances of creating a more peaceful world.

**Section 5:** The bill shall go into effect immediately after passage.

**Section 6:** All laws in conflict with this legislation shall be deemed null and void.
