

A BILL TO ENACT DAPA AND DAPA

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The Deferred Action for Childhood Arrivals, and the Deferred Action for
3 Parents of Americans and Lawful Permanent Residents will be enacted
4 into law. Persons who age out of DACA will be given the opportunity for
5 Permanent residence. The funding for this program, levied through a
6 capping of tax deductions to 28 cents on the dollar for the top 3% of
7 earners, will be used to modernize and improve the immigration process.
8 Excess funding will be diverted back into the general reserve of tax
9 revenue.

10 **SECTION 2.** The definition for “age out” shall be the same as specified in the existing
11 policy as announced in 2012.

12 **SECTION 3.** The U.S. Citizenship and Immigration Services, along with the U.S.
13 Immigration and Customs Agency and the Department of Homeland
14 Security will provide enforcement. The approval of the funding increase
15 will come from the Congressional Budget Office.
16 Go into further details if necessary.

17 A. Modernization will include subsidization of DACA and DAPA
18 fees.

19 **SECTION 4.** This legislation will go into effect one month after the indicated process is
20 completed.

21 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A BILL TO PHASE OUT THE FEDERAL USE OF PRIVATE PRISONS

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States federal government will phase out the use of private
3 prisons and/or for-profit prisons.

4 **SECTION 2.** A private prison or for-profit prison shall be defined as a place in which 5
5 individuals are physically confined or incarcerated by a third party that is
6 contracted by a government agency. Phase out shall be defined as the act
7 of discontinuing a process or project.

8 **SECTION 3.** Immediately from passage, every year the United States will reduce the
9 number of prisoners in private prisons by 20% from the number at the time of passage.
10 Therefore in five years, the use of private prisons shall be completed phased out.

11 A. All contracts with private prison corporations shall be
12 terminated and no new contracts shall be implemented.

13 **SECTION 4.** This legislation will go into effect immediately.

14 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A RESOLUTION TO ENABLE AND PROTECT THE GRID FOR THE 21st CENTURY

1 Whereas: According to a recent multiyear study and analysis completed by the
2 Department of Energy’s *Office of Energy Policy and Systems Analysis* the
3 current U.S. electricity system was developed over more than a century ago and
4 includes thousands of generating plants, hundreds of thousands of miles
5 transmission lines, distribution systems serving hundreds of millions of
6 customers, and billions of end-use devices and appliances, and

7 Whereas: The electricity sector is confronting a complex set of challenges including
8 aging infrastructure; a changing generation mix; growing penetration of
9 variable low/no load growth; climate change; increased physical and
10 cybersecurity risks; and, increasing adoption of distributed energy resources
11 (DERs)

13 will improve the national security, economic competitiveness, and the
14 environmental impact of the energy sector by providing Federally Funded
15 Research and Development Centers sufficient funds to enable and protect the
16 grid for the 21st century.

A BILL TO COUNTER NORTH KOREAN AGGRESSION IN THE PACIFIC

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1A.** The United States will deploy THAAD missile systems in Seoul,
3 South Korea and Hagåtña, Guam to counter the blatant threats posed to
4 our allies by North Korea's continued missile testing.

5 **SECTION 1B.** The United States military will continue to use both the Patriot and the
6 Aegis systems that are currently deployed in the Pacific region.

7 **SECTION 2A.** The Terminal High Altitude Area Defense (THAAD) is a defensive,
8 American anti-ballistic missile defense system designed to intercept
9 short, medium, and intermediate range ballistic missiles.

10 **SECTION 2B.** The Patriot (MIM-104) is a long-range, all-altitude, all-weather air
11 defence system designed to counter tactical ballistic missiles, cruise
12 missiles and advanced aircraft.

13 **SECTION 2C.** The Aegis Ballistic Missile Defense System (ABMD) is program
14 implemented by the United States Department of Defense Missile
15 Defense Agency to provide missile defense against short to
16 intermediate-range ballistic missiles.

17 **SECTION 3.** The United States Special Operations Command and the Department of
18 Defense will oversee the implementation of this bill.

19 **SECTION 4.** This bill will take effect immediately after the passage of this legislation.

20 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
