EVENTS

<u>Lincoln-Douglas debate</u> will use the NSDA September/October 2017 resolution: "Resolved: In the United States, national service ought to be compulsory." Three minutes of prep time.

<u>Public Forum debate</u> will use the NSDA September/October 2017 resolution: "Resolved: Deployment of anti-missile systems is in South Korea's best interest." Two minutes of prep time.

<u>Parliamentary debate</u> will offer a mixture of fact, value, and policy resolutions throughout the tournament that will be mass-announced at the beginning of prep. After the announcement, students will have 20 minutes to prepare.

<u>Student Congress</u> will follow NSDA and CHSSA rules. Students will present 3-minute speeches, followed by one minute of cross-examination. Priority slips will be issued to competitors for the preliminary rounds and will not be replaced if lost.

TECHNOLOGY POLICY

Computers in Parliamentary Debate

Parliamentary debaters MAY use computers to access saved files ONLY during preparation time, but may NOT use the Internet. Parliamentary debaters MAY NOT use computers during rounds.

Computers in Lincoln-Douglas Debate, Public Forum Debate, and Student Congress

During Lincoln-Douglas, Public Forum, and Student Congress rounds, competitors MAY use computers to access saved files, but MAY NOT use the Internet. Competitors MAY use secondary devices such as flash drives and external hard drives during rounds.

Phones

During rounds, students MAY use phones for timing ONLY. Using phones during rounds to access the Internet or to communicate with people is strictly forbidden.

JUDGING COMMITMENT

Schools are required to meet the following judging commitments:

- -One qualified judge per three (3) LD entries or fraction thereof
- -One qualified judge per two (2) Parliamentary debate teams or fraction thereof
- -One qualified judge per two (2) Public Forum debate teams or fraction thereof
- -One qualified judge per six (6) Congress entries or fraction thereof

If your school does not provide judges based on the stipulations above, you will be charged an "uncovered" entry fee IN ADDITION TO the standard entry fee.

All judges are required to judge three preliminary rounds (a double-flighted LD or PF round counts as one round) PLUS the first elimination round, regardless of whether their students qualify to the elimination rounds.

Judges may be asked to judge events other than the event they were signed up for in order to meet a school's judging requirement and the tournament's judging needs.

Judges must attend the judges' orientation on the day of the tournament, which begins at 8:30am.

NAVIGATING TABROOM

de Toledo High School uses the online tabroom.com entry system to facilitate the tournament entry process. This is the only way to enter the tournament. If this is your first time using tabroom.com to register for a tournament, please follow these instructions:

-If you do not already have an account, go to www.tabroom.com and click "Sign Up" in the upper right-hand corner. Fill out the forms and your team's roster.

-Make sure you are logged in, and go to www.detoledo.tabroom.com. Click "Register," then click on the event you wish to register in on the right-hand side. From there, you will be able to add entries

-Click the "Judges" tab to add judges.
