# Sun Warrior LS Season Opener 2017 - RCC T1 (October 13th and 14th)

Solorio Academy is pleased to invite you to the Sun Warrior Season Opener, serving as RCC T1. We will offer competition in novice (first year) and open divisions on the 2017-2018 policy debate topic, "Resolved: The United States federal government should substantially increase its funding and/or regulation of elementary and/or secondary education in the United States." We will follow the 8-3-5 format with 8 minutes of preparation time in both divisions.

#### **ENTRIES / FEES**

The tournament can accommodate no more than 70 teams, to be divided evenly among the six RCC schools and Solorio. That is, no program may register an 11<sup>th</sup> team until everyone else has had an opportunity to register a 10<sup>th</sup> team. Should there be extra space, the tournament reserves the right to invite non-RCC teams to compete. The entry fee for each two-person team is \$45.

#### **CHAPERONES**

Each school must be supervised by an official coach or assistant coach.

#### **JUDGES / STUDENT JUDGES**

Current high school students in their third year of policy debate may judge debates in the novice division. Only adults may judge debates in the open division. Each program must provide one judge for every two teams, in the appropriate division. Judges are obligated to judge one round beyond the elimination of the last team from the program with which they are affiliated. NOTE: In 2017, RCC T1 coincides with every other T1 in the city. Consequently, we are very tight on varsity judges. The tournament may refuse to schedule teams from any program that has not met its judging obligation.

Current high school judges MUST attend a MANDATORY judge meeting prior to the start of Round 1.
