# A Resolution to Amend the Constitution To Prohibit Federal Judges to Hold Office After The Age of 80

- 1 BE IT ENACTED BY THIS CONGRESS HERE ASSEMBLED THAT:
- 2 **RESOLVED,** By two-thirds of the Congress here assembled, that the following article is
- 3 proposed as an amendment to the Constitution of the United States, which shall be valid to all
- 4 intents and purposes as part of the Constitution when ratified by the legislatures of three-

ARTICLE—

fourths of the several states within seven years from the date of its submission by the Congress:

7	SECTION 1:	Article III of the Constitution currently grants federal judges life tenure "during
8		good behavior".
0	CECTION 3.	Fordered in deep consults come constitutions to be letter on increase fordered independent

- 9 **SECTION 2:** Federal judges usually serve until death, holding an important federal judgeship for years even after the onset of dementia, Alzheimer's, and other mental infirmities that would render them unfit for office.
- 12 **SECTION 3:** The average age for the onset of dementia is around 80 years old.
- 13 **SECTION 4:** There is no shortage of potential appointees that are eminently qualified to serve on every level of the federal courts.
- SECTION 5: Setting a mandatory retirement at 80 will prevent many judgeships from being held by persons that are no longer fit for office.
- 17 **SECTION 6**: The Congress shall have power to enforce this article by appropriate legislation.

#### A Bill to Restrict Termination of Presidential Appointees

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2 Section 1. The U.S. Code be amended so that any presidential appointee will require equal
- 3 levels of advice and consent from the Senate for approval and termination.
- 4 Section 2. The current standards of Senatorial confirmation that are required for each federal
- 5 position with a presidential appointee shall become the standards for termination of
- 6 that person from the office.
- 7 **Section 3.** This legislation shall take effect January 1, 2018.
- 8 **Section 4.** All laws in conflict with this legislation are hereby declared null and void.

### A Bill to Automatically Exonerate those who are Wrongfully Imprisoned

1	BE IT ENACTED	BY 7	THE CONGRESS :	HERE ASSEMBLED	THAT:

2	SECTION 1.	The United States will automatically exonerate those who are wrongfully
3		imprisoned. The Department of Justice is required to absolve those who
4		are wrongfully convicted from blame/fault and provide the necessary
5		compensation as per the federal statute.
6	SECTION 2.	Wrongfully convicted people that live in states without a mandatory
7		compensation statute are left on the streets with nothing. They have lost
8		their families, jobs, and reputations. Even though they have been deemed
9		innocent, their lives are still changed forever. Therefore, requiring courts
10		to exonerate wrongfully convicted people will help them financially.
11	SECTION 3.	Enacted and enforced by the Department of Justice
12	SECTION 4.	A person can be awarded up to \$50,000 per year of wrongful
13		imprisonment and up to \$100,000 per year on death row. Paid by the State.
14	SECTION 5.	This legislation will go into effect beginning of 2019 fiscal year.
15	SECTION 6.	All other law and/or passages of Congress that conflict with this will be
16		considered null and void

- 9 **SECTION 5.** This legislation will go into effect on January 1<sup>st</sup>, 2018. All usage of these drones is to be discontinued after this date.
- 11 **SECTION 6.** All other laws and/or passages of Congress that conflict with this bill will be considered null and void.

- display of the Confederate States of America Flag on all government property.
- 4 **SECTION 2.** Banning the Confederate flag's display will clearly show that the government
- 5 does not condone the racist ideals associated with it.
- 6 **SECTION 3.** The Public Buildings Service (PBS) division of the General Services
- Administration (GSA) will enact and oversee this. The GSA will work with local
- and state governments to ensure all Confederate flags have been taken down.
- 9 **SECTION 4.** The General Services Administration will allocate funding from the Federal
- 10 Building Fund sector of its budget.
- **SECTION 5.** This legislation will go into effect in the beginning of 2018 year.
- **SECTION 6.** All other law and/or passages of Congress that conflict with this will be
- considered null and void.

8	Section 3:	There are no costs related to this legislation.
9 10	Section 4:	This legislation will be enacted and enforced by the United States Department of Health and Human Services
11 12	Section 5:	All other laws and/or passages of Congress that conflict with this bill will be considered null and void.


#### A Bill to Abolish Animal Testing for Human Products

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT: 1 2 SECTION 1. The testing of human products on other animals shall be abolished. 3 SECTION 2. Animal: a living organism that feeds on organic matter, typically having specialized sense organs and nervous system and able to respond rapidly 4 5 to stimuli. Products: Something produced by human or mechanical effort or by a 6 7 natural process. Testing: take measures to check the quality, performance, or reliability 8 of (something), especially before putting it into widespread use or practice. 9 10 Abolish: formally put an end to (a system, practice, or institution). 11 12 SECTION 3. This bill will be enforced by the United States Department of Agriculture. SECTION 4. This will be implemented 3 months after passage giving companies 13 ample time to adjust and comply with the change. 14

#### 1 BE IT HEREBY ENACTED BY THIS CONGRESS THAT:


- 2 **SECTION 1.** This bill Nursing Home Reform, will work to reform the way nursing homes

2	SECTION 1.	Recreational Marijuana will be legalized in all 50 states for those ages 21
3		and over. Once upon legalization, a Sales Tax will be placed upon
4		recreational marijuana in all forms. Effects of this bill also include that all
5		people convicted of minor marijuana possession charges will have their
6		cases reviewed for dismissal by the Department of Justice (DOJ). In the
7		case of a dismissal by the DOJ, the individual will have his or her charges
8		on minor marijuana possession expunged from their police record.
9	SECTION 2.	A. Recreational Marijuana should be defined as Marijuana used without
10		medical justification.
11		в. Sales Tax should be defined as a tax imposed by the Federal
12		Government on the sale of goods and services, levied at the point of sale,
13		collected by the retailer and passed on to the Federal Government.
14	SECTION 3.	The Food and Drug Administration (FDA) will oversee the regulation of
15		the sale of recreational marijuana. The Internal Revenue Service (IRS) will
16		implement and enforce the sales tax. The Department of Justice (DoJ) will
17		review the cases of those incarcerated under minor marijuana charges
18		for dismissal.
19	SECTION 4.	This bill will take effect on December 20, 2017.
20	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

## A Resolution to Require Bilingual Education in Public Schools

1	WHEREAS,	Students in public schools lack the critical skill of proficiency in a foreign
2		language; and
3	WHEREAS,	Bilingualism develops the mind, studies have shown that creativity and
4		skills like problem solving, dealing with abstract concepts, analyzation,
5		etc., are increased by studying a foreign language; and
6	WHEREAS,	The study of foreign languages lessens prejudice, since prejudice is
7		caused by preconceived notions of a certain culture due to lack of
8		education on that culture, learning about foreign languages and
9		incorporating the culture that goes along with that language increases
10		knowledge and decreases prejudice. This is much needed at a time in the
11		US where prejudice seems to be getting increasingly worse; and
12	WHEREAS,	The mastering of a foreign language gives more competitive edge when
13		searching for jobs in the future, and only 20% of public school students
14		from K-12 learn a foreign language, while a great majority of private
15		school students, that outnumbers those public school students learning a
16		foreign language, learn a foreign language, as required by the school,
17		giving them an advantage in the marketplace over those who didn't have
18		the money for private school, or never learned a foreign language from
19		an early age or at all in their lifetime; therefore, be it
20	RESOLVED,	That the Congress here assembled make the following recommendation
21		for Public Schools to add a secondary language class apart of the required
22		school curriculum from grades K-12.

## A Bill to Make Narcan more available to Law Enforcement

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2	SECTION 1.	Federal Funds be distributed to every local police department of every
3		state for the purchasing of the lifesaving drug Narcan. The amount of
4		funds distributed to these police departments will be decided based on
5		the needs of each city depending on their amount of drug users and
6		annual overdoses.
7	SECTION 2.	A. Narcan should be defined as a prescription nasal spray medicine that
8		blocks the effects of opioids and reverses an overdose.
9		B. Opioids should be defined as drugs that upon overdosage, causes
10		breathing to slow down or stop, making it difficult to wake from this
11		state. This includes heroin and prescription pain pills like morphine,
12		codeine, oxycodone, methadone, Vicodin, etc.
13	SECTION 3.	The Department of Justice, Office of Justice Programs will oversee the
14		enforcement of this bill along with the determination of the certain
15		needs of each community in regards to addiction and overdose rates.
16	SECTION 4.	This bill will take effect on January 5th, 2017
17	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.
