 - 1 to cover the entry of 6+ students in the House (If so designated, we may trade this judge to speech for a Congress judge.)

 - \$50 for a Senate Judge
 - \$50 for a House Judge
 - \$25 for the second House Judge
 - Note Additional entries requested by the district do not count against a team.
 - <u>New Rule College-age judges must have completed their second year</u> (four semesters). College courses taken in high school for advanced credit do not count toward judge standing.
 - Most NW judges will be shifted to the NE Congress and most NE judges will be shifted to NW

- <u>New Rule We are not using the piloted direct questioning or the</u> piloted evidence rules until they are adopted and published by the <u>NSDA with suitable notice.</u>
- All Presiding Officer nominees <u>must</u> be registered with the District Chair at the time of registration closing (not including any additional time for entry requests from the speech tournament).
- Senate
 - Each school may seat up to two (2) Senators, but it may only seat one (1) if it chooses to set a priority on filling seats in the House. At least one (1) Senator must be seated for a school to count.
 - A district with eight (8) or more schools represented in the Senate will qualify two (2) senators to the National Senate.
 - If fewer than eight (8) schools are represented, no Senate may be seated and members will be shifted to the House.
- House
 - 30 to 60 = 2 chambers with 8 from each advancing to the Super Senate / 2 national qualifiers
 - 61 to 90 = 3 chambers with 6 from each advancing to the Super Senate / 3 national qualifiers
 - Note There are options for fewer than 30 or more than 90, but we will cross those bridges when we come to them. We have never been there.

- For logistical reasons, we will have...
 - Team Central Time
 - Team Eastern Time
 - To be considered for either WSD team, a student must have been entered in an NW Indiana NSDA District Tournament.
 - If necessary, priority will be given to NSDA National alternates.
 - If spots remain available for one team or the other, a student may cross from Central to Eastern or Eastern to Central.
- If a school nominates an individual to a World Schools Debate team from NW Indiana and that student drops, the school will be responsible for any entry fees, judge fees, room fees, and transportation fees owed by the student. If a school wishes to have the student re-pay the amount of the fine, then they must take care of the billing at a later time.
