A Bill to Increase Federal Funding to Impoverished Native American Reservations

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** Poverty rates in Native American Reservations is at an all-time high, as
3 such we should raise the federal funding to meet their needs

4 **SECTION 2.** Native American Reservation shall be defined as any Reservation whose
5 population consists of Native peoples found in the US before the arrival
6 of Christopher Columbus

7 **SECTION 3.** The Department of Health shall oversee the implementation of this bill

8 A. Each Reservation shall Receive up to 100 million Dollars after the
9 poverty and unemployment levels have been assessed by the DOH

10 **SECTION 4.** This legislation shall go into effect 6 months after ratification.

11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A bill to make community college tuition free for all US citizens.

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

Section 1 whereas every citizen should have the right to a degree regardless of financial situation.

Section 2 whereas citizen is legal resident of the United States and degree is a qualification awarded to students upon successful completion of a course of study in higher education, normally at a college or university.

Section 3 Whereas the Department of US Education will oversee the enforcement of this bill along with the enforcement mechanism

Whereas the US government will allocate 10 billion dollars to the enactment of this bill

Section 4 The implementation of this bill will be by the 2020 fall school year.

Section 5 All laws in conflict with this legislation are hereby declared null and void

A Bill Mandate Women to Register for the Draft

BE IT ENACTED BY THE CONGRESS ASSEMBLED THAT:

Section 1: Whereas every citizen should be required to register for the draft regardless of sex

Section 2 : Whereas the US draft refers to the compulsory recruitment for military service. In the status quo only men are required to register at the age of 18. With the enforcement of this bill, all female citizens of the US shall be required to register for the US draft at the age of 18.

Section 3: Whereas the department of military affairs will oversee the enforcement of this bill along with the enforcement mechanism

Section 4: Whereas the implementation of this bill will go into effect January 1, 2018

Section 5 All laws in conflict with this legislation are hereby declared null and void

A Bill To Outlaw Private Credit Reporting Companies and Have the US Treasury take over Credit Reporting Services.

BE IT INTACT BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1: Private Credit reporting companies will be dismantled and have information of personal americans transferred to US Treasure and will take over full duties of credit reporting services. As private companies have to much power with the information they hold.

SECTION 2: Credit reporting agencies are generally one of two types: **reporting** either on individuals or on businesses. The largest consumer **credit reporting agencies** are Experian, Equifax and TransUnion.

SECTION 3: The US Treasury would oversee the enforcement of this bill and if the CEO or person in charge does not hand it over they will be given jail time.

SECTION 4: This Bill will go into effect on July 1st ,2018

SECTION 5: All laws in conflict with this legislation are hereby declared null and void.

A Bill To Outlaw all Genetically Modified Organism's

BE IT INTACT BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1: All US states will not sell, consume, nor produce Genetically Modified Organism 1 (GMO) as their is no research of what they do long term.2

SECTION 2: GMO is an organism whose genome has been altered by the techniques of genetic engineering 3 so that its DNA contains one or more genes not normally found there. 4

SECTION 3: The Department of Agriculture will oversee the enforcement of this Bill 5

- a. The consequence for not following this Bill would be a 1000 dollar fine. 6
- b. A 2nd offense would lead to the offenders selling and distribution licence revoked.7

SECTION 4: This Bill will go into effect January 1st, 2019 8

SECTION 5: All laws in conflict with this legalization are hereby declared null and void

A Bill to Remove Abstinence-Only Sexual Education in all Public Schools

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1. **Section 1:** Whereas the 50 states will hereby be barred for teaching Sex Ed. with the
2. Current pro-abstinence approach. The current approach has been proven ineffective
3. at stopping the spread of STDs and unplanned pregnancies.

4. **Section 2:** Whereas pro-abstinence refers to the teaching of abstaining from sexual
5. actovity and sex ed is the required course for all high schoolers.

6. **Section 3:** Whereas the Department of Education would oversee the implications of
7. this bill.

8. Refusing said approach would result in an investigation and possible punishment for
9. school districts resulting in a possible loss of 5% governement funding.

10. Whereas parents in disagreement with this approach shall hereby be enabled to
11. remove their children from this program. This would leave the responsibility of
12. teaching Sexual Education to said kids with an approach they find appropriate.

13. **Section 4:** Whereas this bill would take effect in the beginning of the new school year
14. (August 2018).

15. **Section 5:** Whereas all laws in conjunction with this bill would be considered null and
16. void.

A Bill to Raise the Smoking Age

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

Section 1: Whereas the US shall raise the smoking age from 18 to 21. With the smoking age being so low, the participants may not realize the harm smoking does to their bodies.

Section 2: Whereas “smoking age” refers to the legal age minimum that individuals are allowed to participate in acts of smoking.
Whereas smoking is the inhaling or tasting of smoke produced by burning substances, most commonly tobacco.

Section 3: Whereas the effects of this bill would be overseen by the Department of Health.

Section 4: This bill would be implemented by the new year of 2020, and would have a 18 month probation period as to view the effects of this change.

Section 5: All laws in conflict with this new law are hereby considered null and void.

A Bill to Officially Make India Our Ally

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** India shall now be designated officially as a major Non-NATO ally.

3 **SECTION 2.** Major Non-NATO Ally shall be defined as any ally nation not associated
4 with The North American Treaty Association that has a strategic working
5 relationship with the United States of America.

6 **SECTION 3.** The United States Department of State and the United States Department
7 of Defense shall jointly hold the responsibility of overseeing the
8 implementation of this legislation.

9 **SECTION 4.** This piece of legislation shall go into effect one year after passage.

10 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Create an India Free Trade Agreement

Introduced for Congressional Debate by Creighton Prep.

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. United States of America will enter negotiation with India on the topic of ending trade tariffs on several economic areas and creating a free trade agreement.

SECTION 2. The key economic areas in question are as follows: agricultural goods, electrical machinery, medical devices, precious stones, pharmaceutical products, textiles, organic chemicals, and mineral fuel.

SECTION 3. This bill will be overseen by the Department of Commerce, the US International Trade Commission, and the US Trade Representative

SECTION 4. This bill will be implemented July 20th 2018.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Increase Post-Disaster Preparedness Within the United States of America

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

SECTION 1a. In every US state and territory, a post-disaster depot will be constructed in an effort to increase post-disaster preparedness and survival

SECTION 1b. Each state and territory will be required to have at least one all-disaster depot, but more can be built depending on population distribution and/or density and these depots can be specialized for region-specific disasters

SECTION 1c. Every citizen of a state or territory is capable of using the depot post-disaster at no cost to them

SECTION 2. The following definitions have been provided for the Congress:

Post-Disaster Depot: a warehouse-type building that contains enough supplies for at least 33% of the population for at least 9 months post-disaster; constructed to survive any possible disasters

SECTION 3a. The United States Department of Homeland Security's Federal Emergency Management Agency (FEMA) shall oversee the implementation of this Congressional bill

SECTION 3b. FEMA will receive a monetary bonus equal to 6% of its current budget to oversee the cost of the required depots

SECTION 4. This bill shall be implemented on the first Monday after passage

SECTION 5. Any laws in conflict with this bill shall be declared null and void
