# A Bill to Fund Biodiversity

# BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United States will fund 1 million dollars from the budget of the Environmental Protection Agency (EPA) to the Fish and Wildlife services to inform and research to protect main pollinators.

# A Bill to Place Restrictions on Early Voting

# BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Early voting in the United States of America will be limited to U.S.
2		citizens who have legitimate reasons for not being able to vote on any
3		given federal election day.
4	SECTION 2.	Early voting (also known as pre-poll voting or advance polling) can be
5		defined as a method in which American voters in a public and, in this case,
6		federal election are able to vote in advance to any given scheduled and
7		specified election day.
8	SECTION 3.	Because early voting can discourage voters from casting ballots as well as
9		be manipulated by candidates to aid them in any specific race, it will not
10		be available to American citizens who do not have legitimate reasons for
11		being unable to vote on a specified scheduled election day.
12	SECTION 4.	U.S. citizens eligible for legitimate early voting will include civilians and
13		those serving in the military who would not be in close proximity to their
14		polling locations on a scheduled election day due to their travel and
15		service. Also, early voting will be allowed for citizens who are mentally
16		physically ill and cannot reach a destination on a specified election day.
17	SECTION 5.	This legislation applies to all United States federal elections and
18		encourages state and local election commissions to assume similar stances.
19	SECTION 6.	This legislation shall go into immediate effect by September 1, 2018.
20	SECTION 7.	All laws conflicting with this legislation shall be declared null and void.

# A Resolution to Amend the Constitution to Allow Foreign-Born Citizens to become **President of the United States**

1	WHEREAS, in 2010, the percent of the U.S. population that was foreign-born was
2	12.9% and rising,
3	WHEREAS, foreign-born US nationals are already required to register for the Selective
4	Service and serve in the Armed Forces,
5	WHEREAS, All U.S. citizens ought to have the right to aspire to the Presidency,
6	therefore, be it
7	<b>RESOLVED,</b> By two-thirds of the Congress here assembled, that the following article is
8 9	proposed as an amendment to the Constitution of the United States which shall be valid to all intents and purposes as part of the Constitution when
10	ratified by the legislatures of three-fourths of the several states within
11	seven years from the date of its submission by the Congress:
12	ARTICLE
13	SECTION 1: In Article II, Section 1, Clause 10, the following lines are hereby
14	stricken: "No person except a natural born citizen,"
15	And replaced by: "All citizens, be they naturalized or native-born, of
16	the United States,"
17	SECTION 2: The Congress shall have power to enforce this article by
	appropriate legislation.

#### A Resolution to Reduce Automobile Accidents

#### Whereas:

- I. Teens are more likely to be involved in a fatal crash than any other age group.
- II. 16-17 year old teens are more likely to be involved in a crash than even 18-19 year olds.
- III. There are 39% percent of teens who reported not wearing their seat belts, in contrast to 9.9% of people overall who do not wear seat belts.
- IV. In crashes involving teenagers ages 16-20, almost a quarter of them were known to have been drinking prior to the accidents.
- V. Per 100 drivers, 16-19 year olds get an average of 36 traffic citations, compared to 17.3 traffic citations per 100 drivers for drivers of all ages.

# Therefore, be it resolved that:

- I. The driving age is increased from 16 years of age to 18 years of age to reduce risk for accidents on the roads overall.
- II. Teenagers aged 18-20 will be issued a junior/probational license with a curfew at 12 p.m.
- III. At age 21, a driver may receive a permanent license if he/she has a driving record free of any serious accidents/citations.
- IV. This bill will be placed into effect on January 1, 2019.
- V. All laws in contrast with this bill are declared null and void on the date January 1, 2019.

	A BILL TO	D BAN PUSH NOTIFICATIONS ON ELECTRONIC DEVICE APPLICATIONS
1	BE IT ENACT	TED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The United States Federal Government will ban all push notifications
3		involving all smartphone, tablet, and other electronic device applications
4		(apps). This will be done to reduce roadway accidents and deaths in the
5		United States, as well as to increase workplace productivity.
6	SECTION 2.	"Push notifications" are defined as messages that pop up on mobile
7		devices from app publishers. Examples of apps with push notifications
8		that this bill will be affecting include, but are not limited to, social media,
9		news sources, games, and general apps.
10	SECTION 3.	A. This legislation will be overseen by the Office of Science and
11		Technology Cooperation (within the Department of State's Bureau of
12		Oceans and International Environmental and Scientific Affairs) and the
13		Department of Treasury.
14		B. Corporations and businesses, which fail to comply with this legislation,

will be penalized of \$50,000 for each incident.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

SECTION 4. This bill shall go into effect on January 1, 2019.

# A RESOLUTION TO HALT THE PRODUCTION OF PENNIES

Whereas: Pennies are becoming useless, expensive, and harmful; and

Whereas: Eliminating the penny is long overdue as there has never been a coin in

and the environmental advantages are huge as well; and

Therefore, be it resolved by this Student Congress here assembled that: The United States

should halt the production of 1 cent pennies effective immediately.

#### A Bill to Provide Additional Funding to Public School Bands

#### BE IT ENACTED BY THE STUDENT CONGRESS ASSEMBLED HERE THAT:

**SECTION 1.** The government shall provide additional funding to <u>public school bands</u>. This will allow public school band programs to purchase new instruments, equipment, uniforms, repair existing instruments, hire additional staff, and participate in more state and national events.

**SECTION 2.** "Public school bands" are defined as a group of student musicians who rehearse and perform instrumental music together, while under the direction and supervision of one or more staff members employed by their school.

#### **SECTION 3.**

- A. The bill will allocate funds to public schools to create and sustain official school supported/led band programs.
- B. A subdivision within the Department of Education the Department of School Supported Music (DSSM) will be created to oversee the creation and funding of official school bands.
- C. Schools that at the time of the DSSM's creation do not have an official band program will be investigated by the DSSM, to determine the necessary amount of funding they require in order to create and sustain one. Schools that already have an official band program will also be investigated, and administered the necessary funds required to sustain it (some schools may not require any additional funding).
- D. To fund this program, an annual budget of \$2 billion will be allotted to the DSSM, based off of initial estimates.

**SECTION 4.** This bill will be enacted immediately, and will continue indefinitely.

**SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# A Resolution Regarding the Use of One-Man Crews

1. WHEREAS	The Federal Railroad Association (FRA) has the power to mandate the

3. WHEREAS	The FRA is set to rule soon on crew sizes for freight railroads,			
4. WHEREAS	The usage of one-person train crews by the Montreal, Maine, and Atlantic			
5.	Railroad may have been a contributing factor in the 2013 Lac Megantic			
6	accident,			
5. WHEREAS	Autonomous train technology is not yet ready for mainline use, be it			
6. RESOLVED	that this Congress here assembled firmly supports the use of two-man			
7.	operating crews on freight and passenger trains, and be it			
8. FURTHER RESOLVED that this Congress implores the FRA to rule as such in its upcoming				

decision.

# A Bill to Institute an Indexed Minimum Wage

Be it Enacted by the House of Representatives and Senate of the United States of America in Congress Assembled,

- 1. SECTION 1: Findings
- 2. The adjust of the minimum wage is subject to contentious political debate.
- 3. Many jobs other than those at the minimum wage are adjusted for inflation.
- 4. SECTION 2: Legislation
- 5. A. The nationwide minimum wage shall be set at a value of \$9.75 per hour, indexed for
- 6. inflation.
- 7. B. The rate of inflation shall be calculated by the Bureau of Labor Statistics using the
- 8. Consumer Price Index method; the basket of goods in the CPI should be updated
- 9. at least a month prior to each new calculation of inflation.
- 10. C. Current exemptions to the federal minimum wage requirement will continue to be applied.
- 11. SECTION 3: Enactment
- 12. A. The Bureau of Labor Statistics shall oversee the calculation of the inflation rate, and is
- 13. allotted \$10,000 to that effect.
- 14. B. This legislation shall be enacted 1 year from passage.
- 15. C. All laws in conflict with this legislation are hereby declared null and void.
