# PRE

### A BILL TO INCREASE GUN CRIME PENALTIES

1	BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1. The United States shall impose stricter penalties for crimes committed involving a
3	portable firearm.
4	SECTION 2. Penalties for crimes are defined as monetary payment, prison sentences, and
5	involuntary servitude applied after a trial.
6	SECTION 3. Portable firearms are defined as any semi-automatic or automatic weapon capable of
7	being legally sold in the United States.
8	SECTION 4. Crimes as defined do not include non-threatening spontaneous brandishing of the
9	weapon, self-defense uses, or carrying of a weapon in a "gun-free" zone.
10	<b>SECTION 5.</b> All monetary fines shall be multiplied by a factor of 2.
11	SECTION 6. All prison or involuntary service time shall be multiplied by a factor of 1.5
12	SECTION 7. Of the funds raised, 30% shall be sent to the NRA for the explicit purpose of

administering firearms safety courses for firearm owners.

### A BILL TO END AID TO PAKISTAN

### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1:** The United States will withdraw all humanitarian and military aid from Pakistan
- **SECTION 2:** Aid will be restored when annual intelligence reports provided to Congress by the State Department determine that Pakistan has ceased support for terrorist groups.
- **SECTION 3:** This act shall not apply with respect to assistance to ensure the security of nuclear weapons.
- **SECTION 4:** USAID and the Department of State shall oversee the implementation of this legislation.
- **SECTION 4:** This legislation shall take effect on the date of enactment.
- **SECTION 5:** All laws in conflict with this piece of legislation shall be declared null and void.

2	Article I:	The sum of \$350,000,000 be hereby allocated for the next fiscal year to			
3		create and support programs and services to aid veterans.			
4	Article II:				
5		a. "Veterans" shall include all those separated from the armed services			
6		with an honorable discharge or general discharge under honorable			
7		conditions.			
8		b. "Programs and services" shall include:			
9		i. Reintegration programs for homeless veterans.			
10		ii. Referral and counseling services for veterans at risk of			
11		homelessness who are transitioning from medical,			
12		rehabilitation and penal institutions.			
13		iii. Financial assistance for supportive services for very low			
14		income veteran families in permanent housing.			
15		iv. A grant program for homeless veterans with special needs.

18	Article III:	This legislation shall take effect immediately upon enactment.			
19	Article IV:	The implementation of this bill will be overseen by the Department of			
20		Veterans Afffairs.			
21	Article V:	All laws in conflict with this legislation are hereby declared null and void.

# A Bill To Ban the Use of Private Military Contractors

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. Beginning January 1st, 2020, the US Armed forces will be barred from the usage of Private Military Contractors (PMCs)
- **SECTION 2.** The Department of Defense will be tasked with the execution and funding of this bill.
- **SECTION 3.** This legislation will take immediately after passage.
- **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.

### A Bill to Eliminate the State and Local Tax Deduction (SALT)

- **SECTION 4.** This bill shall take effect at the beginning of the fiscal year 2019.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Institute a Public Health Care Option to Insure Health Equity

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The Secretary of Health and Human Services shall establish, and offer
3		through the exchanges, a public health insurance option.
4		A. Section 11081 of the Tax Cuts and Jobs Act (concerning the individual
5		mandate) is hereby null and void.
6	SECTION 2.	The public health insurance option shall be made available through the
7		Exchanges, and shall comply with all requirements established under the
8		Patient Protection and Affordable Care Act applicable to health plans
9		offered through the Exchanges.
10	SECTION 3.	The Department of Health and Human Services will oversee the
11		implementation of this legislation, and shall be granted the power to
12		negotiate prices with pharmaceutical companies.
13		A. The Department of Treasury will be responsible for allocating funds
14		from the congressional discretionary budget at the Secretary's
15		direction.
16	SECTION 4.	This legislation shall be implemented on January 1, 2020.

### A BILL TO PREVENT THE PANDEMIC DISEASES FROM ATTACKING THE YOUNG

1	BE IT ENACTE	ED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	A. This bill shall mandate that all children under the age of 18, but over the age of 6
3		months, annually receive the injectable flu vaccine unless given a medical exemption.
4		B. Congress shall create a new division of the Center for Disease Control (CDC) entitled
5		"The Antimicrobial Resistance Task Force". This task force shall be responsible for
6		developing solutions to drug-resistant microbial threats.
7	SECTION 2.	A. "Injectable flu vaccine" shall be defined as
8		B. "Medical exemption" shall be defined as a letter written by a primary care provider
9		enumerated reasons for not adhering to the guidelines stated in Section 1A.
10		C. "Drug-resistant microbial threats" shall be include Clostridium Difficile (CDIFF),
11		Carbapenem-Resistant Enterobacteriaceae (CRE), Neisseria gonorrhoeae, Multidrug-
12		Resistant Acinetobacter, Drug-Resistant Campylobacter, Fluconazole-Resistant Candida
13		Extended Spectrum Enterobacteriaceae (ESBL), Vancomycin-Resistant Enterococcus
14		(VRE), Multidrug-Resistant Non-Typhoidal Salmonella, Drug-Resistant Salmonella
15		Serotype Typhi, Drug-Resistant Shigella, Methicillin-Resistant Staphylococcus Aureus
16		(MRSA), Drug-Resistant Streptococcus Pneumoniae, Drug-Resistant Tuberculosis,
17		Vancomycin-Resistant Staphylococcus Aureus, Erythromycin-Resistant Group A
18		Streptococcus, Clindamycin-Resistant Group B Streptococcus.
19	SECTION 3.	The Department of Health and Human Services in coordination with the Department of
20		Education will oversee the enforcement of this legislation.
21		A. To verify that all minors have received the flu vaccine, the Department of Education
22		will oversee ensuring that students submit medical vaccine receipts to their
23		respective schools.
24		B. Congress shall allocate \$10 billion to creating the "Antimicrobial Resistance Task
25		Force" division within the CDC.
26	SECTION 4.	This bill will take effect on June 1st of 2019.
27	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Reduce Exploitation by Restricting Payday Loan Companies

1	BE IT ENAC	TED BY THE CONGRESS HERE ASSEMBLED THAT:		
2	Section 1.	Restric	ctions will be placed upon payday loan companies in order to	
3		preven	t predation on vulnerable civilians. The sum of total interest	
4		payme	nts will not be allowed to exceed 1.5 times original loan amount;	
5		i.e. the	final repayment cannot exceed 250% of the initial loan.	
6		Additi	onally, if a client is unable to completely pay off their interest	
7		within	6 months of receiving a loan, and they have paid the amount of	
8		money	that they originally borrowed, they will no longer be required to	
9		pay in	terest to the payday loan company.	
10	Section 2.	A.	A payday loan company has individuals borrow a small amount at	
11			a very high rate of interest. The borrower typically writes a post-	
12			dated personal check in the amount they wish to borrow plus a fee	
13			in exchange for cash.	
14		B.	Interest refers to all charges payable by a borrower to a licensee as	
15			a condition to a loan, including fees.

7			for individuals making \$79,945 or more.
8		C.	There will be no more subsidies on student loans.
9	Section 2.	A.	Federal Student Loans are loans made by the federal government
10			that usually offer lower interest rates and have more flexible
11			repayment options than loans from banks or other private sources.
12		B.	Payment withholding is when students with student loan debts
13			automatically have a certain amount taken from their check that is
14			paid toward their loans.
15		C.	Subsidies are a sum of money granted by the government or a
16			public body to assist an industry or business so that the price of a
17			commodity or service may remain low or competitive.

### A Bill to Enact DACA and DAPA

1	Be it enacted by the Student Congress here assembled that:			
2	Section 1.	The Deferred Action for Childhood Arrivals, and the Deferred Action for		
3		Parents of Americans and Lawful Permanent Residents will be enacted		
4		into law. Persons who age out of DACA will be given the opportunity for		
5	-	permanent residence. The funding for this program, levied through a		
6		capping of tax deductions to 28 cents on the dollar for the top 3% of		
7		earners, will be used to modernize and improve the immigration process.		
8		Excess funding will be diverted back into the general reserve of tax		
9		revenue.		
10	Section 2.	The definition for "age out" shall be the same as specified in the existing		
11		policy as announced in 2012.		
12	Section 3.	The U.S. Citizenship and Immigration Services, along with the U.S.		
13		Immigration and Customs Agency and the Department of Homeland		
14		Security will provide enforcement. The approval of the funding increase		
15		will come from the Congressional Budget Office.		
16		A. Modernization will include the subsidization of DACA and DAPA
