A BILL TO AUTHORIZE LETTERS OF MARQUE AND REPRISAL IN CYBER CONFLICT

1	BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:		
2	Article I:	Congress hereby authorizes the President of the United States to issue letters of 3	
3		marque and reprisal to respond to, or prevent, certain acts of cyber-attack upon	
4		critical infrastructures of the United States, and other similar acts of hostility	
5		committed in the future.	
6	Article II:	Letters of Marque and Reprisal are defined by Article I, Sec. 8 cl. 11 of the	
7		Constitution of the United States.	
8	Article III:	This legislation will go into effect at the start of Fiscal Year 2019.	
9	Article IV:	The President is authorized to commission, under officially issued letters of marque	
10		and reprisal, so many of privately equipped persons and entities as, in his/her	
11		judgment, the Department of Defense or U.S. Intelligence Community may require,	
12		with suitable instructions and compensation to the leaders thereof, to employ	
13		electronic eavesdropping and intelligence gathering, computer network attack	
14		(CNA), computer network Exploitation (CNE) and all electronic or digital means	
15		reasonably necessary to attribute, stop, disrupt, deceive, or otherwise render	
16		ineffective cyber-attacks conducted by unprivileged enemy belligerents outside the	
17		geographic boundaries of the United States and its territories, of any co-conspirator,	
18		and of any conspirator who are responsible for cyber-attacks or aggressions	
19		perpetrated against the United States.	
21	Article V:	All other laws in conflict with this new policy shall hereby be declared null and	
22		void.	

A BILL TO END GERRYMANDERING IN THE UNITED STATES

1	BE IT ENACT	TED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	Article I:	According to Article One, Section Two of the United States Constitution,
3		Congressional districts are redistricted every ten years. Districts will now be drawn
4		by computer programs, not elected officials.
5	Article II:	Gerrymandering will be defined as, "to manipulate the boundaries of (an electoral
6		constituency) so as to favor one party or class".
7	Article III:	This bill shall go into effect immediately after its passing; districts will be redrawn
8		every 10 years pursuant to the most recent Census, as according to the Constitution.
9	Article IV:	The United States Census Bureau will oversee the enforcement of this bill. The
10		United States Census Bureau will use the TIGER (Topologically Integrated
11		Geographic Encoding and Referencing) program to draw the districts.
12	Article V:	All other laws in conflict with this legislation are hereby declared null and void.

A BILL TO EXTEND CONCEALED CARRY RECIPROCITY THROUGHOUT THE NATION

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT: 2 Article I: A person who is not prohibited by Federal Law from possessing, transporting, or 3 receiving a firearm, who is carrying a valid ID, and who is carrying a valid 4 Concealed Carry license and/or permit which is issued by a state, can carry or 5 transport a pistol in any and all 50 states, Districts or Territories. When the laws of any state permit private persons or private entities to prohibit or restrict the 6 7 possession of concealed firearms on their property, this shall not be superseded or 8 interfered with by the provisions of this Article. 9 Article II: A valid ID shall be defined as any photo identification, such as a driver's license or 10 non-driver identification card, issued by the subject's state of residence. 11 Article III: This Legislation will go into effect January 1st, 2019. 12 The A.T.F. will oversee the implementation of this bill. Article IV: 13 Article V: All other laws in conflict with this legislation are hereby declared null and void.

A BILL TO SANCTION THE PHILIPPINES

1	BE IT ENAC	TED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2	Article I:	The United States of America shall immediately impose economic sanctions on the
3		Philippines.
4	Article II:	Economic Sanctions are defined as: The United States will not allow the
5		importation of consumer products from the Philippines and will encourage others to
6		join us in this embargo. The United States will prohibit the export of any and all
7		consumer products, industrial equipment, technology, and resources to the
8		Philippines. The United States will immediately suspend the transfer of any
9		military aid and assistance to the Philippines and will encourage others to join us.
10	Article III:	This legislation will immediately go into effect upon passage.
11	Article IV:	The State Department shall be in charge of implementing and enforcing these
12		sanctions. The State Department may consider lifting the sanctions if the following
13		two conditions are met:
14		A. Representatives of the Philippines have delivered to the President of the
15		United States an adequate and plausible plan for future improvement in
16		protecting human rights, AND
17		B. Amnesty International and/or Human Rights Watch report that the
18		Philippines has made significant improvement in its human right record.
19	Article V:	All laws in conflict with this legislation are hereby declared null and void.

A BILL TO SUBSIDIZE CRISPR RESEARCH AND USAGE IN HUMAN SUBJECTS

1	BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:		
2	Article I:	The federal government shall use tax dollars to fund the research and	
3		implementation of CRISPR technologies on human cells with the ultimate	
4		goal of providing affordable gene-editing services for the American public.	
6	Article II:	A. "Tax dollars" shall be defined as federal revenue collected from US	
7		citizens.	
8		B. "CRISPR," which stands for clustered regularly interspaced short 7	
9		palindromic repeats and is a gene-editing tool, shall be defined as unusual	
10		DNA sequences that protect organisms by identifying and attacking viruses.	
12		C. "Fatal diseases" shall be defined as potentially-deadly ailments CRISPR has	
13		already been tested on, such as HIV, as well as future test subjects, such as	
14		zika and cancers.	
15	Article III:	This bill shall go into effect at the start of Fiscal Year 2018.	
16	Article IV:	The Center for Disease Control and Prevention shall partner with publicly funded	
17		universities to carry out CRISPR research and human implementation.	
18	Article V:	All other laws in conflict with this new policy shall hereby be declared null and	
19		void.
